LICENSE FEES AND INFORMATION

302.01 Licenses and tags required.

It shall be unlawful, except as otherwise permitted in these regulations, for any person to engage in hunting, trapping, guiding, fur dealing, fur or game farming, or the business of taxidermy, without having first procured the appropriate licenses or tags as hereinafter provided, and without having such licenses or tags in his actual possession.

302.03 Special provisions.

(a) The resident hunting, trapping and sport fishing license [section 302.02 (e)] may be obtained by the head of any family or one solely dependent upon himself for support for a fee of \$.25 upon proof presented by the applicant that the applicant:

(1) is obtaining, or has obtained during the immediately preceding six months, assistance under any state or federal welfare program to aid the indigent (Workmen's Compensation is

not considered to be welfare), or

(2) has an annual income of less than \$800.00 for the year immediately preceding application, or

(3) has historically been dependent on fish and game for subsistence.

(b) Nonresidents may not take big game animals without previously purchasing numbered, nontransferable, appropriate tags issued to an individual as provided in this Part, which tags must be affixed and locked to the animal immediately upon taking and remain affixed and locked until the animal is prepared for storage, consumed or exported; provided, that tags issued but not used for animals specified above, may be utilized to satisfy the tagging requirements for any of the species above named of which the tag fee is of equal or less evaluation, but only for the year in which the tag is issued.

(c) The Commissioner may issue to any person without cost permits to collect fish and game, subject to such limitations and provisions as he deems appropriate, for scientific, propagative, or educational purposes.

(d) No license shall be required of any resident under the age of sixteen for hunting or trapping.

302.04 License period.

Licenses shall be valid for the period January 1 to December 31 inclusive, of the year for which they are issued.

302.05 Licenses obtainable from.

Licenses are obtainable from any designated issuing agent or by mail from the Commissioner, Alaska Department of Fish and Game, Juneau.

302.06 Lost license or tag.

Any person who loses either his license or tag(s) may procure replacements by applying to the Commissioner, Alaska Department of Fish and Game, Juneau.

302.07 License violations.

Any false statements as to any material fact in an application for license shall render null and void the license issued upon it; any person who shall make any false statement in such an application shall be guilty of a violation of these regulations. Any person who shall alter, change, loan or transfer to another person any license or tag issued to him pursuant to these regulations, or any person who shall use any license or tag other than the one issued to him, shall be guilty of a violation of these regulations.

SEASONS AND BAG LIMITS

311.01 General provisions.

It is lawful to take game only in the Game Management Units open to such taking in accordance with the open seasons and bag limits prescribed in the following Sections of this Part.

NON-RESIDENT HUNTERS

All non-residents must hire a registered guide to hunt or photograph brown, grizzly, or polar bear, or to hunt sheep, goat and walrus. Guide Registers are available on request.

INSTRUCTIONS FOR REGISTRATION—ONLY MOOSE HUNTS

1. All persons desiring to hunt bull moose in **Unit 6**, or antlerless moose in **Units 7, 14, 15, 16 and 20** must apply for registration. Qualified applicants will be registered and may participate in registration-only hunts as provided for above.
2. To qualify for registration applicants must:
 - (a) Possess a valid hunting license (except residents under 16 years of age).
 - (b) Not have previously taken a moose during a regular 1962 moose season.
3. All qualified registrants will receive a metal locking seal. Seals will be valid only under the following conditions:
 - (a) Provided that the seal is used only in the area for which issued.
 - (b) Provided that the seal is used only by the hunter to whom it is issued.
4. It shall be unlawful to transport a moose from the place of kill unless the metal locking seal is securely locked to the lower jaw in such a manner that the seal cannot be removed without first being broken.

5. All participants in these hunts must, within 3 days after the close of the hunts and during office hours, personally report to one of the previously mentioned offices of the Alaska Department of Fish and Game or the Fish and Wildlife Service office at Kenai. Successful hunters in Unit 6 and that portion of Unit 20 described above bounded by the Tanana, Gerstle, and Little Delta Rivers and the crest of the Alaska Range must report within 24 hours. At the time successful hunters report they must surrender the the animal's lower jaw, and, if the moose was taken in Units 6, 7, 14, 15 or 16, present for examination the scalp with both ears attached; unsuccessful hunters must surrender their unused seals. A report form shall be filled out at this time.

(h) BISON

Fifty (50) bison of the Delta Herd have been declared available for the three uses listed below. Priorities between (a) and (b) shall be established by the Commissioner, and they shall take precedence within the stated limitations over (c).

- (a) All or a portion of said bison may be granted to persons, groups, associations, partnerships, or corporations for raising and breeding as domestic stock for commercial, scientific, or educational purposes pursuant to Chapter 15, SLA 1962, and the procedures established under its authority.
- (b) All or a portion of said bison may be transplanted as game animals by the Department to areas it designates.
- (c) Animals remaining available after August 15, 1962, or being too old to be of a utilitarian purpose are to be hunted by permit. Procedures governing hunting will be established by the Department and made known to the public by supplemental announcement.

Applications for the acquisition of bison in accordance with (a) above should be directed to the Commissioner.

METHODS AND MEANS

Game animals are classified as Big Game, Small Game, Fur Animals, Marine Mammals, and Unclassified Game (see Definitions). Certain methods, means, and types of equipment may **not** be used to take **any** of these. Other methods, means, and types of equipment are not prohibited for all game, but only for one or more categories. A summary of the legal and illegal ways of taking game is provided below. The full text of this part of the regulations (Part 303) may be obtained from the Secretary of State, Juneau. Copies are available for examination at Department offices.

GENERAL PROVISIONS: PERTAIN TO ALL GAME

Illegal methods and means of taking **any** game:

1. Shooting from, on, or across a highway
2. Using poisons, smoke, chemicals, bombs, explosives, or set guns
3. Helicopters (including transportation of hunters, hunting gear or game)

BIG GAME

Legal methods and means of taking big game are:

1. Shotguns, but not larger than 10 gauge and not capable of holding more than 3 shells
2. Rifles or pistols using centerfire cartridges
3. Bow and arrow (except for brown or grizzly bear in Units 1 through 5)

Illegal methods and means of taking Big Game include, in addition to those listed under General Provisions:

1. Shotguns larger than 10 gauge or capable of holding more than 3 shells
2. Rifles or pistols using rimfire cartridges
3. Shooting from an aircraft, motor vehicle, or motor boat (unless the boat is beached)
4. Machine or submachine guns, pits, deadfalls, snares or steel traps, radio communications, artificial salt licks, fire, artificial light
5. While such animals are swimming (except polar bears)

METHODS and MEANS—(Continued)

6. Dogs (except for black bear in Units 14 and 16 during the month of October)

7. Any other means not specified as legal above

SMALL GAME

Legal methods and means of taking small game are:

1. Shotguns (not larger than 10 gauge and not capable holding more than 3 shells)

2. Rifles, pistols, bow and arrow, spears, snares

3. Hawks, falcons

4. With the aid of a dog

Illegal methods and means of taking small game include, in addition to those listed under General Provisions:

1. Shooting from a motor vehicle

2. In the case of waterfowl, any method prohibited in the Waterfowl Supplement to these regulations or in the Federal Migratory Bird Regulations.

3. Any other methods or means not listed as legal above

FUR ANIMALS

Legal methods and means of taking fur animals include:

1. Steel traps (with the exceptions noted below under illegal means)

2. Rifles or pistols

3. Snares

4. A fyke or blackfish net

Illegal methods and means of taking fur animals are, in addition to those listed under General Provisions:

1. Shotguns, artificial lights, dogs

2. Conventional steel traps with a jaw spread over 9 inches

3. A net or fish trap (except a blackfish or fyke net)

4. Disturbing or destroying the dens of fur animals

IT IS ALSO ILLEGAL:

1. For persons under 11 years of age to take beaver

METHODS and MEANS—(Continued)

2. To take beaver by **any** means except steel traps or snares (except that firearms may be used in Unit 8 only)

3. To take land otter with steel traps having a jaw spread of less than $5\frac{7}{8}$ inches during any closed season on mink or marten in the same Unit

4. To take mink by any means except steel traps or snares in Units 1 through 6

5. To take wolves or coyotes by use of an aircraft or, during the closed season on other fur animals, with steel traps or snares, except under authority of a permit which may be issued by the Commissioner

MARINE MAMMALS

Legal methods and means of taking marine mammals are:

1. A shotgun (not larger than 10 gauge and not capable of holding more than 3 shells)

2. A rifle, pistol, net or harpoon

Illegal methods and means of taking marine mammals, in addition to those listed under General Provisions, include:

1. Any methods not listed as legal above

UNCLASSIFIED GAME

Legal methods and means of taking Unclassified Game include:

1. Rifles, pistols, shotguns

2. Traps, snares, nets

3. Any other methods not specifically prohibited under General Provisions or under illegal means, below

Illegal methods and means of taking Unclassified Game, in addition to those given under General Provisions are:

1. A conventional steel trap with a jaw spread over 9 inches

307.01 General provisions.

Unless otherwise provided within each Section of this Part, all areas listed in this Part are continuously closed to the taking

307.02 **Birch Lake Closed Area (near Fairbanks).**

On and within $\frac{1}{2}$ mile of Birch Lake.

307.03 **Harding Lake Closed area (near Fairbanks).**

On and within $\frac{1}{2}$ mile of Harding Lake.

307.04 **University of Alaska Closed Area.**

Posted lands in the vicinity of the University of Alaska, the College and Farmers Loop Roads, and the Steese Highway, which lie within Secs. 27, 28, 29, 31, 33, 34 and 35, Twp. 1 N., R. 1; Sec. 36, Twp. 1 N., R. 2; Sec 6, Twp. 1 S., R. 1; and Sec. 1, Twp. 1 S., R. 2; all west of the Fairbanks Meridian.

307.05 **Paxson Closed Area (in Unit 13).**

The eastern drainage of Gulkana River lying west of the Richardson Highway between the north end of Paxson Lake and the Denali Highway (closed on moose only).

307.06 **Ward Lake Closed Area (near Ketchikan).**

On and within $\frac{1}{2}$ mile of Ward Lake (closed to the taking of big game only).

307.07 **Connell Lake Closed Area (near Ketchikan).**

On and within $\frac{1}{2}$ mile of Connell Lake (closed to the taking of big game only).

307.08 **Anan Creek Closed Area (in Unit 1).**

The drainage of Anan Creek on the Cleveland Peninsula (closed to the taking of black bear only).

307.09 **Berners Bay Closed Area.**

The entire drainage into Berners Bay, located on the east side of Lynn Canal (closed to the taking of moose only).

307.10 **Cooper Landing Closed Area.**

Beginning at the junction of the Sterling Highway and the National Forest boundary, thence north along the National Forest boundary to Thurman Creek, thence southeasterly along Thurman Creek and the northeast side of Trout Lake and beyond to the confluence of Juneau Creek and Falls Creek, thence easterly

CLOSED AREAS—(Continued)

along Falls Creek and the North Fork of Falls Creek and over the connecting saddle to Devils Creek, thence southeasterly along Devils Creek to its confluence with Quartz Creek, thence southwesterly along Quartz Creek to the Sterling Highway, thence westerly along the Sterling Highway to the point of beginning. (Closed to the taking of mountain sheep and mountain goat only.)

307.11 Denali Closed Area.

That part of Unit 13 lying north of the Denali Highway from and including the McClaren River drainage to the westernmost bank of the Susitna River and its source, the Susitna Glacier, (closed on big game only).

307.12 Dyea Closed Area.

The entire drainage into Taiya Inlet, located at the head of Lynn Canal. (Closed on moose only.)

307.13 Juneau Closed Area.

The strip within $\frac{1}{4}$ mile of the mainland coast between Thane and Eagle River (near Juneau). (Closed on fur animals only).

307.14 Kalgin Island Closed Area.

Kalgin Island in Cook Inlet near Anchorage. (Closed on moose only).

307.15 McNeil River Closed Area (in Kamishak Bay).

The entire watershed of McNeil River which empties into the head of Kamishak Bay in lower Cook Inlet. (Closed on brown and grizzly bear only).

307.16 Portage Glacier Closed Area.

The drainages of Portage Creek and its tributaries south of the Alaska Railroad Whittier track (Closed between May 1 and September 30 on big game only).

307.17 Pack Creek Closed Area (on Admiralty Island).

The entire watershed of Pack Creek, which empties into Seymour Canal near the north side of the entrance to Windfall Harbor, containing approximately 21 square miles. (Closed on brown and grizzly bears).

CLOSED AREAS—(Continued)

307.18 Rainbow Closed Area (on Turnagain Arm).

The drainage into Turnagain Arm north of the Anchorage-Seward Highway from Potter to the point where the Alaska railroad crosses the Anchorage-Seward Highway near Girdwood. (Closed to the taking of mountain sheep and mountain goat only).

307.19 Sheep Mountain Closed Area.

Beginning at Caribou Creek Milepost 107 Glenn Highway, thence easterly along the Glenn Highway to Milepost 123, thence along a line going north to Squaw Creek, thence downstream to Caribou Creek and downstream to the point of beginning. (Closed to the taking of mountain goat and mountain sheep only).

307.20 Southeastern Alaska Highway Closed Area.

A strip $\frac{1}{4}$ mile wide on each side of the following highways or described portions thereof in Southeastern Alaska (Units 1, 2, 3 and 4). (Closed on big game only).

(a) Ketchikan area: The North and South Tongass Highway systems and the Ward and Connell Lake road systems.

(b) Wrangell area: The Stikine (Zimovia) Highway from the Wrangell city limits to Milepost 9.

(c) Petersburg area: The Mitkoff Highway from the Petersburg city limits to Milepost 18.

(d) Juneau area: The Glacier Highway from the Juneau city limits to Milepost 20; all of the Mendenhall Loop Road; the Douglas Highway; the north Douglas Road from the Juneau city limits to Milepost 9; all of the Thane Road; the Lena Point Loop Road.

(e) Sitka area: All of the Halibut Point Road; Sawmill Creek Boulevard from the Sitka City limits to the pulp mill.

(f) Haines area: That portion of the Lutak Road between the Chilkoot Bridge and Chilkoot Lake.

307.21 Steese Highway Closed Area.

The area near Eagle Summit lying within 2 miles of each side of the Steese Highway between the bridge across Ptarmigan Creek and a point 8 miles northeast along said highway. (Closed on caribou only).

CLOSED AREAS—(Continued)

307.22 Sullivan Island - Taiya Closed Area.

All of the drainage into Lynn Canal north of the latitude of Point Sherman in Southeastern Alaska. (Closed to the taking of deer only).

307.23 Thayer Mountain Closed Area (on Admiralty Island).

Beginning at the foot of the waterfall at the mouth of Hasselborg River on Salt Lake, head of Mitchell Bay, thence along the easterly bank of the Hasselborg River to the outlet of Hasselborg Lake, thence along the west shore of said lake to the outlet of the creek flowing into the head of the lake, thence upstream along the east bank of said creek to the trail crossing, thence in a southwesterly direction along the trail to the head of Thayer Lake, thence along the easterly shore of said lake to the extreme southern end of the lake, thence southeasterly approximately 2 miles in a straight line to the west end of Salt Lake at the head of Mitchell Bay, thence along to the line of mean high tide of Salt Lake to the foot of the waterfall on Hasselborg River, the place of beginning, containing approximately 60 square miles. (Closed on brown and grizzly bears only).

307.24 Mendenhall Closed Area (near Juneau).

The Mendenhall Peninsula west of the Glacier Highway but not including Mendenhall Flats in Game Management Unit 1. (Closed to hunting).

307.25 Coronation Island Closed Area (in Southeastern Alaska).

All of Coronation Island. (Closed to hunting and trapping).

307.26 Mt. Bullard Closed Area (near Juneau).

The Southwest face of Mt. Bullard. (Closed to the taking of mountain goats only).

307.27 Lost Lake Closed Area (near Fairbanks).

On and within $\frac{1}{2}$ mile of Lost Lake. (Closed to the taking of big game only).

307.28 Besboro Island Closed Area (in Norton Sound).

Besboro Island and adjacent territorial waters (Closed to hunting).

STATE GAME REFUGES AND SANCTUARIES

308.01 General provisions.

The taking of game by hunting or trapping, otherwise permitted by these regulations, is prohibited or restricted on all areas designated as State Game Refuges or Sanctuaries, as provided in this and the following Sections of this Part.

308.02 Aleutian Islands State Game Refuge.

All of the Aleutian Islands are closed to hunting and trapping with the following exceptions:

(a) Umnak, Atka, Unimak, Unalaska, Akun, Akutan, Sanak, and Tigalda Islands are open to hunting and trapping in accordance with Alaska Game Regulations.

(b) Adak, Unimak, Shemya, Attu and Great Sitkin Islands are open to waterfowl and ptarmigan hunting in accordance with Alaska Game Regulations.

308.03 Bering Sea State Game Refuge.

St. Matthew and Hall Islands and Pinnacle Islet in the Bering Sea are closed to hunting.

308.04 Bogoslof Islands State Game Refuge.

Bogoslof Islands are closed to hunting and trapping.

308.05 Chamisso Island State Game Refuge.

Chamisso Island is closed to hunting and trapping.

308.06 Forrester Island State Game Refuge.

Forrester Island and adjacent rocks are closed to hunting and trapping, except that sea lions may be taken for commercial purposes under the terms of a permit which may be issued at the discretion of the Commissioner.

308.07 Hazen Bay State Game Refuge.

Nunivakchak and Krigegag Islands in Hazen Bay are closed to hunting and trapping.

308.08 Hazy Islands State Game Refuge.

Hazy Islands in southeastern Alaska are closed to hunting and trapping, except that sea lions may be taken for commercial purposes under the terms of a permit which may be issued at the discretion of the Commissioner.

STATE GAME REFUGES and SANCTUARIES—(Continued)

308.09 **Kenai State Game Refuge.**

The area corresponding to the Kenai National Moose Range on the Kenai Peninsula is open to hunting and trapping in accordance with Alaska Game Regulations.

308.10 **Kodiak State Game Refuge.**

The area on Kodiak Island corresponding to the Kodiak National Wildlife Refuge is open to hunting and trapping in accordance with Alaska Game Regulations.

308.11 **Nunivak Island State Game Refuge.**

Nunivak Island in the Bering Sea is open to hunting and trapping in accordance with Alaska Game Regulations.

308.12 **St. Lazaria Island State Game Refuge.**

St. Lazaria Island at the entrance of Sitka Sound is closed to hunting and trapping.

308.13 **Semidi Islands State Game Refuge.**

The Semidi Island Group is closed to hunting and trapping.

308.14 **Tuxedni Islands State Game Refuge.**

Chisik, Egg and the other small islands in Tuxedni Harbor, Cook Inlet, are closed to hunting and trapping.

308.15 **Walrus Islands State Game Sanctuary.**

Round Island, Crooked Island, High Island, Summit Island, The Twins, and Black Rock in Bristol Bay and the adjacent state waters are closed to the taking of walrus only.

POSSESSION AND TRANSPORTATION

305.01 **General provisions.**

Game and parts thereof, live game, and nests or eggs of birds legally taken may be possessed in, imported into, or exported from Alaska by any person at any time subject to the restrictions and limitations of the following Sections of this Part.

305.02 **Polar bear and walrus.**

No person shall possess or transport within, import into or export from Alaska any walrus or polar bear, or parts thereof unless such animals have been taken in Alaska or on the High

POSSESSION and TRANSPORTATION—(Continued)

Seas adjacent to the coast of Alaska in accordance with the seasons, bag limits, and licensing provisions of these regulations.

305.03 Nests, eggs and live game.

No person shall take, possess, transport or release in Alaska, or import into or export from Alaska, any nest or egg of a bird or any live game other than domestically produced eggs or animals of species historically domestic in character, except in accordance with the terms of a permit that may be issued at the discretion of the Commissioner.

305.04 Possession of game.

No person shall possess or transport any game or parts thereof not taken by himself unless he furnishes upon request of any official authorized to enforce these regulations a written statement of the name, address and license or permit number of the person from whom such game or part thereof was obtained, or furnishes other information sufficient to establish the manner in which lawful possession was obtained.

305.05 Evidence of sex and identity.

(a) No person shall possess or transport any mountain sheep unless the horns accompany such animal.

(b) Whenever and wherever the taking of any big game species is restricted to one sex, no person shall possess or transport the carcass of that species of big game which is not accompanied by sufficient portions of the external sex organs, or the head (with horns or antlers attached if present) to indicate conclusively the sex of the animal. Provided, however, that nothing contained in this Section shall apply to the carcass of any big game animal which has been cut and placed in storage or otherwise prepared for consumption upon arrival at the location where it is to be consumed.

305.06 Sealing required: bear, beaver and sea otter.

No skins of beavers, sea otters, or brown, grizzly, or polar bears, whether taken within or without the State shall be possessed, transported, or exported from the State until the same shall have been sealed or tagged with a Board-prescribed seal or tag; provided, however, that persons taking brown, grizzly or polar bears

POSSESSION and TRANSPORTATION—(Continued)

within the State may possess unsealed skins thereof for 30 days after taking and within the same period may transport the same unsealed skins for the purpose of having them sealed by an authorized representative of the Department; and provided, further, that persons taking beaver within the State may possess the untagged or unsealed skins thereof during the open season and for 30 days thereafter and within the same period may transport the same untagged or unsealed skins for the purpose of having them tagged or sealed by an authorized representative of the Department. Raw bear hides taken prior to January 1, 1961, and processed bear hides are exempt from provisions of this section.

305.07 Exportation of skins.

The raw skins of wild fur animals may not be shipped, mailed or otherwise transported out of Alaska without properly executing an Export Permit (shipping tag) and an Export Report (post card) as provided by the Department and available from the Department or any post office or commercial carrier.

The Fur Export Permit shall be attached to the outside of any package containing raw skins of wild fur animals for export and shall include a statement of the number and kind of skins contained in the package and a certification that such skins were legally taken and possessed. No carrier or post office may accept for shipment out of Alaska any skins of wild fur animals unless such shipment has a Fur Export Permit attached thereto.

Prior to exporting the skins of wild fur animals, the Fur export Report, detached from the Fur Export Permit, shall be properly executed and mailed to the Department of Fish and Game.

PERMITS AND REPORTS

306.01 Permits required.

The activities described in this Section are permitted only in accordance with the terms of a permit that may be issued at the discretion of the Commissioner. Application for such permit shall be in writing to the Alaska Department of Fish and Game, Juneau, Alaska, provided, however, that a permit and report form for the exportation of furs may be obtained from the Department, any post office or commercial carrier or his transportation agent; and provided, further, that permits to engage in activities de-

PERMITS and REPORTS—(Continued)

scribed in (c), (d) and (l) of this Section may be obtained at any field office of the Department.

(a) Taking any species of game for scientific, educational, exhibition, propagation, or taxidermy purposes when regulations otherwise prohibit their taking.

(b) Taking, holding, importing or releasing any live game.

(c) Taking wolves and coyotes from an airplane.

(d) Setting, maintaining, or attending traps or snares for wolves or coyotes, or other fur animals upon which there is no closed season, during the closed season on mink, land otter, weasel, fox, wolverine, lynx and marten in the respective Units.

(e) Exporting skins of wild fur animals.

(f) Using poison for the taking of any game.

(g) Possessing the skins of sea otter.

(h) Taking moose or bison in special permit hunts as prescribed in these regulations.

(i) Using explosives or bombs in taking marine animals.

(j) Buying, selling, bartering or exporting raw ivory.

(k) Taking sea lions for commercial purposes or for use in the business of fish, fur, or game farming.

(l) Taking wolverine at times other than the regular open season as prescribed in Section 311.03 (Seasons and Bag Limits).

306.02 Reports required.

Reports are required as described in this Section.

(a) A report of activities authorized by permits cited in the above Section (306.01) must be made in accordance with instructions thereon to the Commissioner prior to or upon the expiration of such permits.

(b) A written report must be made to the Alaska Department of Fish and Game within 15 days after the taking of game in defense of life or property detailing the circumstances of such taking.

(c) The purchase or acquisition through consignment or barter of furs or hides of game shall be reported to the

PERMITS and REPORTS—(Continued)

Department of Fish and Game, on forms provided for this purpose, within 30 days of the close of each calendar month in which such business is transacted.

306.03 Harvest tickets required.

All persons intending to hunt sheep must first obtain non-transferable harvest tickets for this species. These may be procured without cost from any licensing agent or Alaska Department of Fish and Game office. The number of each harvest ticket at the time of issue must be entered on the hunter's license, unless the hunter is a resident under 16 years of age who is not required to have a license.

Immediately upon taking a sheep, the hunter must affix the harvest ticket to the animal as instructed on the ticket. The post card form must be filled out and mailed within 30 days after the animal is taken. Unsuccessful hunters must fill out and mail the post card portion of the harvest ticket by January 31, 1963. Failure to comply with the provisions of this Section constitutes a violation of these regulations.

SPECIAL PROVISIONS

304.01 Emergency taking.

Nothing in these regulations shall prohibit any person from taking game, except migratory birds, for food during the closed season in case of dire emergency, nor shall they prohibit the taking of game in defense of life or property, provided, however, that reasonable effort must be made to protect life and property by means other than the destruction of game. Any game taken in defense of life or property is the property of the State and shall be surrendered upon demand to any official authorized to enforce these regulations. The Department of Fish and Game must be notified of such taking as soon as possible, and a written report giving the circumstances of the taking of game in defense of life or property must be made to the Department within 15 days of such taking.

304.02 Wanton waste.

It shall be unlawful for any person wantonly to waste or unnecessarily destroy any game taken in the State of Alaska; provided, however, that this shall not apply to game which the

SPECIAL PROVISIONS—(Continued)

Department declares by regulation to be of a destructive, noxious or nuisance character. The flesh of all small game and all big game except bears must be salvaged for human consumption; provided, however, that either the hide or the flesh of bears must be salvaged for human use.

304.03 Game as animal food or bait.

The use of game as food for dogs or fur animals or as bait is prohibited with the following exceptions:

- (a) Hide, skin, viscera, or bones of any game.
- (b) skinned carcasses of bears or fur animals.
- (c) Marine mammals.

304.04 Purchase and sale.

Purchase, sale or barter of game or parts thereof is permitted with the following exceptions:

(a) The meat of big game and small game other than hares and rabbits.

(b) The skins of grizzly and brown bears, unsealed or untagged beaver and sea otter.

(c) The skulls, horns, or antlers of Alaska big game animals other than naturally shed antlers, or horns or antlers which have been completely removed from the skull by a cut or break through the horn or antler material. Provided, however, that licensed taxidermists may sell unclaimed finished trophies, under authority of a permit issuable at the discretion of the Commissioner, after such trophies have been held one year.

(d) Raw ivory, without a permit which may be issued by the Commissioner or his authorized representative.

304.05 Inspections.

Each fur dealer and taxidermist shall allow any person authorized to enforce these regulations to enter at all reasonable hours and inspect the premises where fur dealing or taxidermy is being carried on and to inspect the books and records relating thereto.

304.06 Excerpt from Federal Migratory Bird Regulations.

In Alaska, Eskimos and Indians may take, possess, and transport, in any manner and at any time, auks, auklets, guillemots, murres, and puffins and their eggs for food and their skins

SPECIAL PROVISIONS—(Continued.)

for clothing, but the birds and eggs so taken shall not be sold or offered for sale. (Section 6.5 of Part 6, Chapter 1, Subchapter 13, Title 50, Code of Federal Regulations).

304.07 Taking of polar bear, walrus and sea otter on the High seas.

The taking of polar bear, walrus and sea otter on the High Seas by residents of Alaska is permitted only in accordance with the seasons, bag limits, methods and means, and licensing provisions that presently pertain to the taking of these animals in Alaska and its Territorial Waters.

DEFINITIONS

301.01 Application of definitions.

For the purposes of these regulations, terms used in this Chapter are defined as set forth in this Part.

301.03 Bag limit.

Bag limit means the greatest number of a game species permitted to be taken by any one person in the Unit in which taking occurs; provided, that additional numbers of a species may be taken in another designated open Unit where a greater limit on such species is prescribed. In no case shall the total or cumulative bag for one person exceed the limit set for the Unit in which the additional game was taken; provided, however, that caribou taken north of the Yukon River shall not apply to caribou bag limits south of the Yukon River.

301.05 Big game animals.

Big game animals means deer, moose, caribou (including feral reindeer), elk, mountain sheep, mountain goat, bison, musk-ox, brown bear, grizzly bear, polar bear, and black bear (including blue and cinnamon color phases).

301.07 Board.

Board means the Alaska Board of Fish and Game.

301.09 Closed season.

Closed season means the time during which game may not be taken.

DEFINITIONS—(Continued)

301.11 Commissioner.

Commissioner means the Commissioner of the Alaska Department of Fish and Game.

301.13 Cub bear.

Cub bear means young bear in their first or second year of life.

301.15 Fur or game farming.

Fur or game farming means the business of propagating, breeding, raising or producing game in captivity for the purpose of marketing such game or its products. The word "captivity" means having the game under positive control, as in a pen, pond or an area of land or water which is completely enclosed by an escape-proof barrier.

301.17 Fur animals.

Fur animals means beaver, muskrat, marmot, raccoon, squirrels (red, ground and flying), fox, lynx, marten, mink, weasel, sea otter, land otter, wolverine, coyote, wolf, excepting domestically raised fur animals.

301.19 Fur dealing.

Fur dealing means engaging in the business of buying, selling or trading in animal skins. The term shall not apply to a hunter or trapper selling the animal skins he has legally taken, or to a person, other than a fur dealer, purchasing animal skins for his own use.

301.21 Game.

Game means all species of birds and mammals, including feral domestic animals, found or that may be introduced in Alaska, except domestic birds and mammals; provided, however, that "game" as herein defined is further classified by regulation as big game, small game, fur animals, marine mammals and unclassified game.

301.23 Highway.

Highway means the surface of any constructed road open to the public.

301.25 Hunting.

Hunting means the taking of big game, small game, unclassified game, marine mammals, and foxes (in Game Management

DEFINITIONS—(Continued)

Units 8 and 10 only), wolves, coyotes and wolverines when taken by means other than steel traps or snares.

301.27 Marine mammals.

Marine mammals means walruses, hair seals, sea lions, porpoises and belugas.

301.29 Nonresident.

Nonresident means any person who does not qualify as a resident as herein defined.

301.31 Open season.

Open season means the time during which game may lawfully be taken. Each period of time prescribed as an open season shall include the first and last days thereof. Whenever the word year is used in Part 311 (Seasons and Bag Limits) it shall mean from July 1 to the following June 30, inclusive.

301.33 Person.

Person means the singular or the plural, including individuals, associations, partnerships or corporations unless the context otherwise requires.

301.35 Raw Ivory.

Raw Ivory is any walrus tusk or tooth which has not been endowed with functional, cultural or aesthetic qualities by altering its natural form or surface through carving, drilling, cutting, filing or engraving. Raw ivory is not altered, in the connotation of this definition, by surface polishing or mounting the ivory in a skull or part thereof.

301.37 Resident.

Resident means a person who for twelve consecutive months has maintained a permanent place of abode within the State and who has continually maintained his voting residence in the State; and in the case of a partnership, association, joint stock company, trust, or corporation, resident shall mean one that has its main office or headquarters in the State; provided, however, that any member of the military services who has been stationed in the State for the immediately preceding twelve consecutive months shall be considered a resident, and the dependents of any such member, who has been living in the State for the immediately preceding year shall likewise be considered a resident; provided, fur-

DEFINITIONS—(Continued)

ther, that a person who is an alien, but who for three years has maintained a permanent place of abode within the State, shall likewise be considered a resident.

301.39 Small game.

Small game means waterfowl, including ducks, geese and brant; Wilson or jacksnipe; all species of grouse and ptarmigan; snowshoe and arctic hares and rabbits.

301.41 State.

State means State of Alaska.

301.43 Take.

Take means taking, pursuing, hunting, trapping or in any manner disturbing, capturing or killing or attempting to take, pursue, hunt, trap or in any manner capture or kill game.

301.45 Taxidermy.

Taxidermy means the tanning, mounting, processing, or other treatment or preparation of fish or game, or any parts thereof, as a trophy, for monetary gain, including the receiving of such fish or game or parts thereof for such purposes.

301.47 Three-quarter curl horn.

Three-quarter curl horn means the horn of a mature mountain sheep, the tip of which has grown through three-quarters of the circle described by the outer surface of the horn as viewed from the side.

301.49 Transport.

Transport means shipping, carrying, importing, exporting, or receiving or delivering for shipment, carriage or export.

301.51 Trapping.

Trapping means the taking of game declared by regulation to be fur animals, except foxes (in Game Management Units 8 and 10 only), wolves, coyotes, and wolverines when taken by means other than steel traps or snares.

301.53 Unclassified game.

Unclassified game means all species of game not otherwise classified in these definitions.

CLOSED AREAS AND REFUGES

Check carefully the list of Closed Areas and Refuges. It's **your** responsibility to be sure the area you wish to hunt in is open to hunting.

LICENSES

The fact that there is no closed season and no bag limit on some species (including crows, ravens in some areas, and some small animals) does not mean that they can be taken without a license. Make sure you have your license **in your pocket** when you are hunting or trapping.

LIVE ANIMALS

Holding or transporting live game animals is illegal without a permit. **Do not pick up live baby animals.** If you think they have been abandoned, call nearest Department of Fish and Game office. Many wild animal mothers leave their offspring alone for several hours at a time.

READ ALL THE REGULATIONS

There are many special provisions and restrictions, written for the protection of both game and people. Knowing the law is **your** responsibility.
