Alaskan Northwest Natural Gas Transportation Company ("Applicant" or "Alaskan Northwest") hereby files an application for authority to construct, operate, connect and maintain facilities on the International Border, State of Alaska, United States of America, and the Yukon Territory, Dominion of Canada, pursuant to Executive Order 10485 and Section 153.10 of the Commissions Regulations under the Natural Gas Act, 15 USC§717 et seq.

In support thereof, Applicant shows as follows:

I.

II.

IDENTIFICATION OF APPLICANT

The exact legal name of Applicant is Alaskan Northwest Natural Gas Transportation Company. Alaskan Northwest is a partnership organized and existing under the laws of the State of New York. Members in this Partnership are all subsidiaries of major natural gas transmission companies. 1/

Northwest Alaskan Pipeline Company ("Northwest Alaskan") has been selected by the Alaskan Northwest partnership as its operating partner. Northwest Alaskan is authorized to do business in the States of Alaska, Utah, Montana, California, Idaho and the District of Columbia. Northwest Alaskan's principal place of business is 136 East South Temple, P.O. Box 1526, Salt Lake City, Utah 84110.

III.

BACKGROUND OF THE APPLICATION

Concurrently with this application, Alaskan Northwest is filing its application for a final certificate of public convenience and necessity, pursuant to Section 7 of the Natural Gas Act and Section 9 of the Alaskan Natural Gas Transportation Act of 1976, to construct and operate the Alaskan segment of ANGTS. Specifically, Alaskan Northwest has requested authority to construct and operate a 48-inch diameter natural gas pipeline extending approximately 743 miles from the Prudhoe Bay Area on the North Slope of Alaska to a point of interconnection with the proposed facilities of Foothills Pipe Lines, (Yukon) Ltd. ("Foothills") on the Alaska-Yukon Border, all as more fully set forth in such application.

The instant application requests the authority, pursuant to Executive Order 10485, to construct, operate, connect and maintain facilities on the International Boundary between Alaska and the

Yukon Territory to permit the transportation and delivery of Prudhoe Bay gas to the Foothills system. All of the gas which will be delivered by Applicant to Foothills (adjusted for heating value less fuel and unaccounted for gas) will be transported and redelivered to the lower 48 states of the United States.

IV.

LOCATION OF BORDER FACILITIES

The facilities which Applicant proposes to construct, operate, connect, and maintain at the International Boundary are a fully enclosed meter building, four 24-inch diameter by 39-foot long meter runs, and a section of 48-inch pipe which will connect with the proposed pipeline of Foothills at the International Boundary point. Applicant proposes no other facilities at or near the Boundary point.

The point of crossing of the Alaska segment of the ANGTS at the International Boundary will be about two miles south of the Alaska Highway intersection with the Alaska-Yukon border near Milepost 743. The location of the metering station is planned in the vicinity of the nearby U.S. Customs Border Station.

The proposed location of the pipe section and meter station is set forth on the map which appears in Appendix A, attached hereto.

V.

Neither Applicant nor any of its facilities will be owned wholly or in part by any foreign government or directly or indirectly subventioned by any foreign government, nor does Applicant have any understanding for any such ownership or subvention from any foreign government.

VI.

CONTRACTS

There is no contract existing or contemplated between Applicant and any foreign government or private concern which in any way relates to the control or fixing of rates for the purchase, sale, or transportation of Alaskan natural gas.

VII.

OTHER LICENSES OR PERMITS

No landing license or permit has been granted to Applicant or any predecessor by any foreign government or by any agency of a foreign government in connection with the exportation of natural gas here involved. Shippers who plan to use Applicant's facilities for the transportation of gas will be responsible for obtaining any necessary authorizations for the importation of the Alaskan gas into Canada and its exportation to the lower 48 states.

VIII.

NOTICE

A form of notice suitable for publication in the Federal Register is attached to this Application.

WHEREFORE, Applicant respectfully requests that a Presidential Permit be issued to it pursuant to Executive Order 10485 authorizing the construction, operation, connection and maintenance of facilities on the International Boundary between the United States and Canada as more fully described hereinabove.

NOTICE

Take notice that on June 30, 1980 Alaskan Northwest Natural Gas Transportation Company (Alaskan Northwest) a New York partnership whose mailing address is P.O. Box 1526, Salt Lake City, Utah 84110, filed an application for a Presidential Permit for the construction and operation of facilities on the International Boundary between the State of Alaska, United States and Yukon Territory, Dominion of Canada in connection with the construction and operation of the Alaska segment of the Alaska Natural Gas Transportation System (ANGTS), pursuant to Executive Order No. 10485.

Alaskan Northwest is a partnership whose members are affiliates of major natural gas transmission companies and is the successor-in-interest to Alcan Pipeline Company (Alcan), which was granted a conditional certificate of public convenience and necessity to construct and operate the Alaska segment of the ANGTS by the Commission on December 16, 1977, in accordance with the President's Decision and Report on an Alaska Natural Gas Transportation System.

Alaskan Northwest states in its application that it will construct a meter station and related facilities at the International border. Further it states that no contract exists with a foreign government or private concern that would control the cost of the natural gas and that no foreign government directly or indirectly will control the facilities. All the directors of Alaskan Northwest are U.S. citizens.

Applicant has filed concurrently here with an application for a final certificate of public convenience and necessity authorizing the construction and operation of the Alaska segment of the ANGTS pursuant to Section 7(c) of the Natural Gas Act and Section 9 of the ANGTA.

Any person desiring to be heard should file a petition to intervene with the Federal Energy Regulatory Commission, 825 North Capitol Street N.E., Washington, D.C. 20425, in accordance with the Commission's Rules of Practice and Procedure. All such petitions should be filed on or before _____.
