Re: tailings dam design at proposed Donlin Gold mine

DAM 3

On behalf of the individuals listed below, I urge you to take a hard look at the potential impacts of a full tailings dam failure, and to establish the strongest protections possible to mitigate tailings dam failures. The proposed 464-foot high tailings dam for the Donlin mine would be the highest tailings dam in the state. A dam failure would release harmful contaminants into the Kuskokwim River, which supports the largest Chinook salmon subsistence fishery in the state. Development of the mine and the indefinite monitoring long after the mine is closed will have permanent impacts on not only the Chinook salmon, but other fish and subsistence resources that residents depend on.

DAM 4

Given the increased rate of tailings dam failures globally, and the significance of downstream resources, tailings dam safety is of paramount concern at the proposed Donlin gold mine. I respectfully call upon agencies and governments involved with the Donlin gold mine project Draft EIS to:

- 1) Incorporate the model results of a tailings failure that involves a partial tailings spill of 20-25% of the tailings dam capacity to more accurately understand the risks, and thoroughly evaluate the long-term risks of mercury and selenium loading to fisheries from a tailings spill.
- 2) Include full consideration of life cycle costs including the risk costs of failure, direct and indirect, and other externalities to provide a more complete economic picture.
- 3) Adopt the recommendations of the Mount Polley expert panel to prioritize public health and safety over economics as the driving factor in determining the preferred alternative.
- 4) Incorporate a regulatory requirement for an Independent Tailings Review Board.

DAM 6

5) Provide a comparison of the probability of and impact of failure of the operating pond in the Dry Stack alternative relative to the probability and impact of failure of different-sized spills at the proposed wet slurry tailings impoundment. This would provide a more thorough analysis of the two mine alternatives.

DAM 8

6) Include analysis of blind earthquakes and earthquakes on currently unknown faults in estimates of peak ground acceleration and other seismic impacts that might be experienced by Donlin facilities.

DAM 2

The potential impacts of a tailings dam failure to residents of the region and their traditional ways of life would be devastating. One resident puts it this way:

*My family has lived in Nikolai, Alaska, which is the last village on the top of the Kuskokwim, and any breach in tailings dam would affect our subsistence lifestyle in regards to marine life. We recently heard about contamination as a result of the Red Devil Mines which were in operation during the 1960s and we have people trying to convince us that there is no danger. There is a very valid reason why Pebble Mine is stalled and this will affect the future of our families and we cannot allow this to happen. We are being told that our economy will improve with more jobs and Nikolai has had one person (and we are probably being cast in a bad light because of the performance of this one individual) work for Donlin Gold since it's inception so we don't see that jobs are in our future and will only benefit a few in the immediate area of Donlin Gold.*

Therefore, I urge the US Army Corps of Engineers to take a hard look at the potential impacts of a full tailings dam failure, and to establish the strongest protections possible to mitigate tailings dam failures.
