My name is John Runkle. I am a resident of the village of Nikolai and a co-lease holder at a site in the Western Alaska Range. The lease was issued to me and my father in law, Philip Esai, by the BLM in 1987 for our joint commercial guiding operation. Philip is a lifelong resident at Nikolai.

The Donlin Creek Mine proposed gas pipeline route that is indicated on their maps show the route passing to within 2 miles of our long established camp on the Khuychanik Creek. We currently have 8 buildings at our lease location. Our extended families have subsisted in this immediate area by traditional and customary gathering, hunting and trapping for over 60 years in modern time. Is it permissible for me to send you via email a comment regarding this subject? Mail is limited to one day a week here at Nikolai, depending upon weather. I realize that it is close to a deadline for March 28 for comments. However, the concerns my family and I have as well as other people that have been long term established along the proposed route has come to our attention. Specific parts of the proposal are the cause for our concern. Please advise me on this matter at your earliest convenience.
