

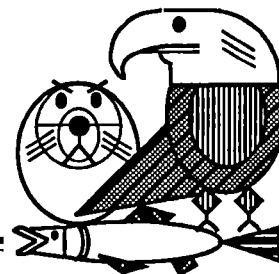

Trustee Council Pursues Restoration

Anchorage—The Exxon Valdez Oil Spill Trustee Council moved forward with a comprehensive approach to restoration and recovery of the resources injured by the 1989 spill at their meeting Tuesday.

"The Trustees' actions will provide a balanced approach to full restoration of the Alaskan ecosystem injured by the oil spill," said newly-appointed Executive Director Jim Ayers.

At the November 30 meeting the Trustee Council approved projects ranging from Kodiak to Prince William Sound. The Trustees approved a Draft Restoration Plan which will guide all future restoration actions, adopted a mission statement to help focus future Trustee actions, released the list of proposed 1994 projects for public review, approved funding for an Alutiiq Archaeological Artifact Repository in Kodiak, and reviewed the agenda for the Prince William Sound ecosystem workshop scheduled this weekend in Cordova.

The Draft Restoration Plan outlines an ecosystem approach which includes general restoration, monitoring and research, and habitat protection.

The draft plan, which still must comply with the National Environmental Protection Act process, will be used to guide annual decisions on how to spend the bulk of the civil settlement monies.

The myriad of general restoration projects proposed for the coming year include a project to restore sockeye salmon in Prince William Sound to replace

salmon lost as a result of the oil spill, work to remove oil from mussel beds, and treatment of oiled beaches near the village of Chenega.

Monitoring and research projects under consideration include the development of a world-renowned marine research institute to be located in Seward. Some other related research projects include fisheries projects to determine the causes of recent drops in pink salmon and herring populations in Prince William Sound and sockeye on the Kenai Peninsula, and projects to assess the condition of various indicator species such as marine mammals and seabirds.

Action planned on habitat protection includes evaluation and ranking of additional parcels of land for their importance to species injured by the spill. The Trustees also directed Ayers to initiate tentative discussions with the owners of seventeen parcels which were already highly ranked.

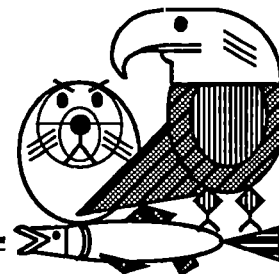
Also at their November 30 meeting the Trustees received an update on the Ecosystem Workshop scheduled in Cordova December 4 through 6 to develop an ecosystem study for Prince William Sound. Workshop participants will define problems occurring in Prince William Sound, hypothesize causes and work to identify possible solutions.

In addition, the Trustees for the first time approved a mission statement which emphasizes restoring the injured ecosystem, "while taking into account the importance of quality of life and the need for viable opportunities to establish and sustain a reasonable standard of living."

"It's been two years of long hard work to get the restoration to this point," said Ayers. "I'm confident that the process will result in wise use of the settlement funds to benefit the entire nation as well as Alaskan residents and the injured ecosystem in the spill area."

Anchorage—The draft plan to guide use of funds to restore resources and services injured by the *Exxon Valdez* oil spill was approved by state and federal officials at their November 30 meeting.

The *Draft Restoration Plan* outlines the policies developed by the *Exxon Valdez* Trustee Council after extensive public comment on two preliminary documents released in 1992 and 1993. The plan is available for public review now and will be sent out for formal public comment concurrently with the Draft Environmental Impact Statement for the plan. Copies are available at the Oil Spill Public Information Center.

This Trustee Council meeting was the first to take place since appointment of new Executive Director Jim Ayers.

"The Trustees made a lot of critical decisions at this meeting," Ayers said. "It was an ideal point for me to come on board." The Trustees hired Ayers to move restoration activities into a second phase of work with adoption of the Restoration Plan and approval of development of an ecosystem planning approach.

The Restoration Plan incorporates nine general policies, each addressing an issue that was raised during public discussions. The policies specify that:

- the restoration program will take an ecosystem approach;
- restoration activities may be considered for any injured resource or the service it provides;

- most restoration activities will occur within the spill area; a few restoration activities may occur elsewhere in Alaska;
- restoration activities will emphasize resources and services that have not recovered from injuries sustained as a result of the 1989 spill;
- activities must have a relationship to an injured resource, benefit the same user group that was injured and should be compatible with the character and public uses of the area;
- competitive proposals will be encouraged;
- restoration projects will be subject to independent scientific review;
- meaningful public participation will continue to be actively solicited; and
- government agencies involved will be funded only for restoration work that they do not normally conduct.

Other actions and issues discussed during the Trustee Council meeting included:

- The Trustees reviewed the *Comprehensive Habitat Protection Process: Large Parcel Evaluation & Ranking* document, which evaluated and ranked eighty-one land parcels of one thousand acres or more for their importance to species injured by the spill. The Trustees then directed Ayers to initiate discussions with the owners of seventeen parcels of privately owned land in Prince William Sound, on the Kenai Peninsula and in the Kodiak region which received high rankings.
- The Trustees directed Ayers to send the Draft 1994 Work Plan out for public review and comment. The document should be distributed around December 13, staff members said. The draft plan will include a proposed Alaska Marine Research Institute to be located in Seward and dedicated to research and monitoring of marine mammals and seabirds to aid in their long-term recovery.
- Funding was approved for the Alutiiq Archaeological Repository in Kodiak.
- The 1993 Shoreline Survey Assessment project report was delivered by Project Leader Ernie Piper and geomorphologist Dr. Jim Gibeaut. They reported that oil residue—either surface or subsurface—was present at every one of the 59 study sites the team visited in Prince William Sound and the Kenai region. They also noted that overall oiling is markedly reduced, and that the effects of cleanup work are becoming more apparent over time as indicated by reductions in oil remaining at sites which were cleaned more aggressively. Gibeaut said there was also a substantial decrease in subsurface

oil found from 1991 to 1993. He noted that the rate of decrease is slowing, however, and speculated that it may take another four years to see the amount of improvement noted between 1991 and 1993.

- The Trustees reviewed the agenda for an Ecosystem Workshop sponsored by the Council to take place in Cordova December 4 through 6. This workshop is the result of the Trustees commitment to develop an ecosystem study for Prince William Sound. Workshop participants will define problems occurring in Prince William Sound, hypothesize causes and work to identify possible solutions.

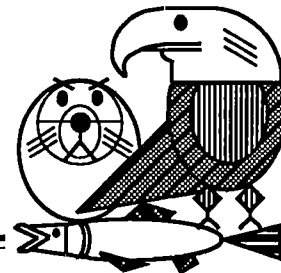

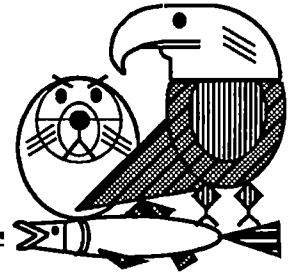

Exxon Valdez Oil Spill Trustees Appoint Executive Director

Anchorage — The Exxon Valdez Oil Spill Trustee Council today unanimously approved a motion to offer Jim Ayers of Juneau the position of Executive Director of Trustee Council operations.

In this position Ayers would direct restoration planning and management under the October 1991 civil settlement between the state and federal governments and Exxon. Ayers is currently Director of the Alaska Marine Highway System, and has served the State of Alaska previously in a variety of resource management posts, including Deputy Commissioner of the Alaska Department of Fish and Game.

"We're excited about putting Mr. Ayers in this post," said Trustee Charles Cole, Alaska Attorney General. "We think this selection will give an indication to the people of the state and the country that we are serious about moving things forward with restoration, enhancement and acquisition in the spill affected region that will help to bring balance to an environment injured by the 1989 spill."

"The job with the Trustee Council is the opportunity of a lifetime to do good things for people, the environment and the resources," said Ayers. "I intend to work closely with the state and federal trustees and the people in the spill affected region. I'm very proud to serve and I'm confident we can reach agreement quickly on terms and conditions of the job."

Ayers has nearly 20 years of experience in private enterprise and public administration, much of it resource-related. In addition to his work at the state ferry system and the fish and game department, he has worked extensively with rural, coastal Alaska communities. He holds a bachelor of science degree in economics and industrial management from Purdue University, and an M.S. in administration from the University of Oregon.

"The Department of the Interior appreciates the commitment on the part of the state trustees in choosing an extremely qualified person to serve as Executive Director," said George Frampton, Assistant Secretary for Fish, Wildlife and Parks. "This is an excellent example of the spirit of cooperation between the state and federal governments."

The Trustee Council in a separate motion approved a recommendation to Ayers of Molly McCammon as Assistant Director, noting that selection of key staff members will be one of Ayers' immediate priorities. Ayers said that he intends to meet with McCammon soon to discuss the position.

McCammon has specialized in fisheries management issues for both the state fish and game department, as a special assistant to the commissioner, and as staff to several state legislators representing Western Alaska coastal communities.

The Trustees commended Interim Administrative Director Dave Gibbons, who was appointed to that post at the Trustees' first meeting in December of 1991.

"Dave and the staff have done a tremendous job to bring us through this extremely fluid period in the formative stages of the trustees operations. Dr. Gibbons has done an exceptional job in helping the Trustee Council to steer through this difficult period and deserves a great deal of credit and thanks," said Steve Pennoyer, NOAA Trustee.

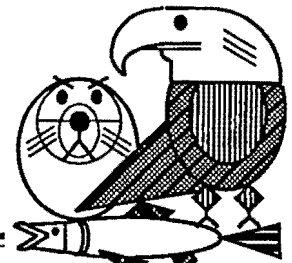

Large Response Received to Spill Restoration Plan

Anchorage—More than 2,000 people expressed their views in writing or in person this summer about a draft Exxon Valdez oil spill Restoration Plan document, government officials said. A summary of those responses was released at a meeting of the Exxon Valdez Oil Spill Trustee Council in Anchorage yesterday.

The Trustee Council sent out 33,000 copies of a Summary of Alternatives brochure in April, requesting comments by the August 6 deadline. The Trustees received 799 completed questionnaires and another 792 letters telling them how the public thinks the \$900 million in civil settlement funds being paid by Exxon over ten years should be spent. Approximately 500 people also commented at 22 public meetings in the oil spill affected region during April.

More than 90% of those responding said that habitat protection or acquisition should be part of the final restoration plan. Approximately 665 respondents said that some portion of the money should be allocated to monitoring and research projects, and about 80% of those who addressed this issue said the Trustee Council should also undertake other monitoring activities, such as for an ecological monitoring program.

In addition, about 60% of the people who responded favored spending some money on direct restoration projects, such as cleaning residual oil from beaches and mussel beds, fisheries projects and projects to help subsistence resources.

Approximately two-thirds of the responses received by the Trustee Council favored putting some of the money aside in the form of an endowment. Of those who favored an endowment, two-thirds said that the earnings should be used to fund long-term monitoring and research.

The Trustee Council took action on a number of other issues during the Thursday and Friday meeting in Anchorage, including:

- Eight projects proposed for the 1994 Work Plan were approved for interim funding because of time-critical activities which much be undertaken while the Trustees consider the full 1994 budget.
- The Trustees approved an interim three month reduced administrative budget.
- Negotiations with Eyak Corporation continued for purchase of critical habitat lands in the Cordova area which are slated for clear-cutting. The Trustees will resume the negotiations with Eyak on Monday in an executive session by teleconference.
- The Trustees approved printing 4,000 copies of the Proceedings from the Exxon Valdez Oil Spill Symposium, which took place in Anchorage last February. The Proceedings will be available for \$35 early in 1994.
- The Trustees approved payment of costs associated with production of final reports on studies conducted in the 1993 field season.
- Initial work to develop an integrated ecosystem study plan was approved, at a cost of \$7,500.

Trustee Council Responds to GAO Report

Anchorage—The Exxon Valdez Oil Spill Trustee Council yesterday voted to request that the General Accounting Office revise a report critical of the Trustee's actions. The Trustees moved to ask the GAO to reissue "Use of Exxon Valdez Oil Spill Settlement Funds," released on Monday, and to include the Trustee's written responses to criticisms in the report.

Alaska Attorney General Charles Cole led the way in criticizing the briefing prepared at the request of Representative George Miller (D-CA), Chairman of the House Committee on Natural Resources, calling the report 'scandalous.'

The Trustees moved to send a letter requesting that the GAO take into consideration written responses to be prepared by the Trustees. Several of the Trustees pointed out that GAO standard operating procedure when preparing similar reports is to provide the agency being reviewed a copy of the draft document and allow time for written responses to be prepared. These comments are then incorporated into the final report prior to its release. The Trustees said that portions of the report are inaccurate, and that they need the opportunity to correct the record.

The GAO report notes that the GAO staff did show a draft of the report to the Trustees, and take oral comments, but Alaska Department of Fish and Game Commissioner Carl Rosier stated that he had only about an hour to review the document prior to the discussions, and other Trustees said they only had the document about three hours. The GAO did not allow the Trustees to keep the draft copies.

The vote was 5-0, with the Department of the Interior representative, Assistant Secretary George Frampton, abstaining.

The Trustee Council took action on a number of other issues during their Monday meeting in Anchorage, including:

- At the request of the Public Advisory Group, the Trustees voted to seek advice from the U.S. Department of Justice on the legality of setting up an endowment using settlement funds.
- The Trustees passed a motion to encourage the Forest Service to continue discussions with Eyak Corporation regarding protection of critical habitat areas near Cordova. The Trustees also amended their motion to request that the visual qualities of Orca Narrows, one of the tracts under discussion, be preserved until the September 16 Trustee Council meeting.
- The Trustees asked the Restoration Team to develop a study to conduct biological surveys concentrating on Prince William Sound for inclusion in the 1994 Work Plan. The Trustees set aside \$5 million for this purpose.
- The Public Advisory Group submitted candidates names for individuals to serve as alternates to PAG meetings when necessary, and the Trustees approved those selections.

The Trustee Council, consisting of three state and three federal officials, was formed in 1991 to administer spending of the \$900 million in civil settlement funds gained in 1991 when Exxon Corp. settled with the governments for damages sustained to natural resources and services as a result of the Exxon Valdez oil spill of March 1989. Settlement funds are to be paid out by Exxon over a ten year period; to date \$240 million has been received by the trust fund.

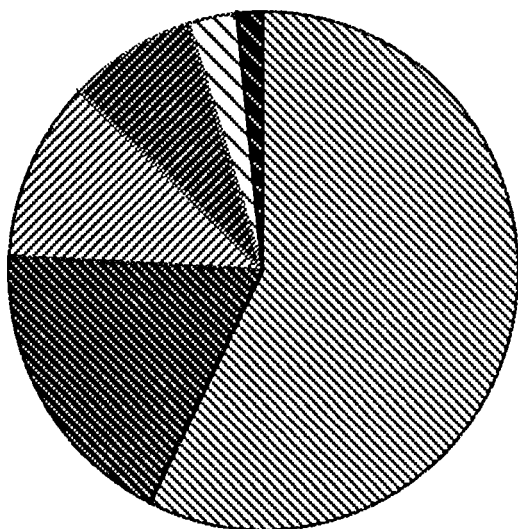

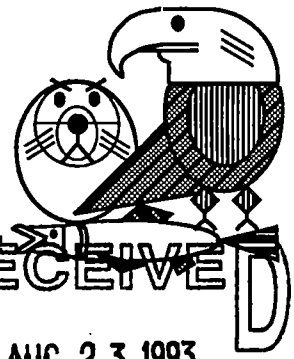

Trustee Council Responds to GAO Report

Several of the Trustees pointed out that GAO standard operating procedure when preparing similar reports is to provide the agency being reviewed a copy of the draft document and allow time for written responses to be prepared. Miller states that "at your office's request, we did not obtain written agency comments on a draft of this report." The Trustees said that portions of the report are inaccurate, and that they need the opportunity to correct the record.

TRUSTEE COUNCIL MAKES OFFER TO PROTECT EYAK LANDS

JUNEAU, Alaska -- The Exxon Valdez Trustee Council, on Monday, August 9, adopted a resolution offering The Eyak Corporation \$41 million to protect important fish and wildlife habitat on the Native Corporation lands in the Cordova area. The council offer was formally transmitted by letter to the corporation today.

In their offer, the six-member Trustee Council proposes to buy 10,250 acres of Eyak lands in the immediate vicinity of Cordova and to acquire a conservation easement prohibiting timber harvesting on 8,100 acres in the Orca Narrows-Nelson Bay area. In addition, the offer includes a timber harvesting moratorium and option on the remaining Eyak lands, approximately 110,000 acres, until April 1, 1994, for a price to be negotiated. This would allow the Trustee Council time to study the lands and determine if further protection measures are needed.

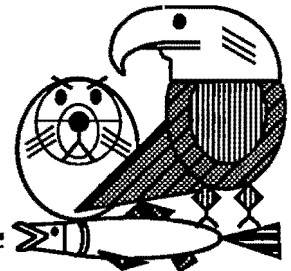

Fact Sheet: Restoration Actions of the Exxon Valdez Oil Spill Trustee Council As Of July 1993

On October 8, 1991, the U.S. District Court in Anchorage approved an agreement to settle claims of the United States and the State of Alaska against Exxon Corporation for various criminal violations and for recovery of civil damages resulting from the 1989 Exxon Valdez oil spill. The civil settlement specified that the State of Alaska and the Federal Government receive \$900 million over the following ten years to restore the resources and associated services injured by the spill. Six Trustees — three state and three federal — were appointed to administer the civil settlement funds.

The Trustees for the State of Alaska are the Commissioners of Fish and Game and Environmental Conservation and the Attorney General; the Federal Trustees are the Secretaries of Agriculture, Commerce, and Interior. The Federal Trustees have appointed their lead representatives in Alaska to serve on the Trustee Council.

The Trustee Council is using funds from the settlement to restore injured resources and associated services. Exxon makes its annual restoration payments to a Joint Trust Fund held by the U.S. District Court for allocation by the Trustee Council. A total of \$240 million of the \$900 million civil settlement has been paid by Exxon as of July 1993.

The Trustee Council adopted a Work Plan in 1992 and 1993 with a mix of restoration projects to implement. Just over \$52 million was committed to these annual work plans. Over 71% of that amount was allocated for restoration projects. Other allocations from the \$52 million have funded final data collection, data analysis and preparation of final reports for damage assessment studies. Other funds from the settlement have been used for reimbursement of certain expenses incurred by the state and federal governments for damage assessment, cleanup work and litigation

related to the Exxon Valdez oil spill; and administrative activities necessary to support the work of the Trustee Council and the Restoration Team.

A major task for the Trustee Council is to complete a plan to guide decision-making throughout the life of the settlement. A Summary of Alternatives for Public Comment was released to the public as a brochure in April of 1993.

Two actions have been taken thus far in 1993 to protect important areas of habitat under imminent threat: purchase of private inholdings in Kachemak Bay State Park (near Homer), and commitment to purchase lands in Seal Bay on Afognak Island (near Kodiak). The \$7.5 million for purchase of Kachemak Bay inholdings are included in a \$20 million Habitat Protection Fund approved in the 1993 work plan. The Seal Bay action is not reflected in the following tables because negotiations are not finalized. At the direction of the Trustee Council, negotiations are currently underway for protection of threatened habitat at three additional locations; two in Prince William Sound and one on the Kenai Peninsula.

The following tables highlight projects from the 1992 and 1993 work plans in the categories of: general restoration projects, actions taken to protect habitat critical to species and associated services injured by the spill, recovery monitoring projects, and projects undertaken as necessary precursors to conducting restoration activities.

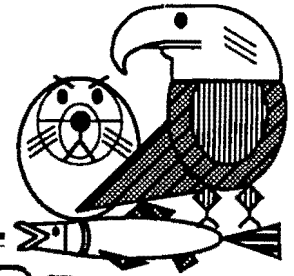

Release Date Changes for Draft EVOS Restoration Plan

Anchorage -- The Exxon Valdez Oil Spill Trustee Council decided during their June 1 & 2 meetings to delay release of the Draft Environmental Impact Statement and Draft Restoration Plan until after they've had time to consider all the public comments responding to the Draft Restoration Plan Summary of Alternatives brochure, which was released in April. The public comment period for consideration of the restoration alternatives listed in the brochure ends August 6, 1993.

"It will definitely be to the Trustee's benefit to be able to take into consideration all of the comments from the public on the brochure," Trustee Council Interim Administrative Director Dave Gibbons said. "This will help ensure a better plan, which more closely fits both the injuries observed and the public's stated desires about restoration priorities."

Trustee Council staff now expect to develop a Draft Restoration Plan for public review in the fall of 1993 and the Trustees will adopt a final Restoration Plan in 1994. This change in scheduling will not adversely affect the progress of restoration work, Gibbons said.

"The Trustees decided to use the Draft Restoration Plan as a guide for final decisions on the 1994 Work Plan. This won't slow down restoration projects because final decisions on the 1994 Work Plan will take place in December, which fits in well with this change in schedule," Gibbons said.

"The Trustees plan is that the Alternatives brochure, Restoration Plan, Environmental Impact Statement and each year's Work Plan will all be part of an integrated restoration program which will continue over the life of the settlement agreement," Gibbons said. Exxon will make annual payments into the court-administered fund until 2001.

Trustee Council staff conducted a series of 22 public meetings in Alaska during April and heard many of the same questions and concerns repeated in different communities. In order to address those questions and concerns, the Trustees directed staff to prepare a package of additional information for release to the public, available upon request. The information packet will include:

- detailed information about how the Trustees have allocated money received from Exxon so far as part of the settlement,
- more and updated information on resources injured and services lost or reduced by the spill,
- information about a change in the boundary of the spill area defined by the Trustees,
- information on the process involved in habitat protection,
- examples of options for general restoration, and
- information about how a monitoring and research program could be organized and carried out.

Staff from the *Exxon Valdez* Oil Spill Trustee Council will be visiting villages and towns in the oil spill affected region during April to ask citizens for their answers to that question before the Council makes long-term decisions on spending over \$600 million in restoration funds.

A series of public meetings are scheduled to take comment on a brochure summarizing the *Draft Exxon Valdez Oil Spill Restoration Plan*. We will be holding a meeting on Thursday, April 22, 7:00 p.m. at the City Council Chambers to take comment from your community to be used in preparing the final Restoration Plan. We welcome your participation in this meeting.

You should soon receive a brochure providing information about various restoration options. This document, which is a summary of the draft Restoration Plan, asks a number of questions and outlines strategies for the restoration of resources damaged by the March 24, 1989 Exxon Valdez oil spill. These restoration activities will use funds obtained in the October 1991 settlement negotiated among the state and federal governments and Exxon. Our meeting will be structured around the information in this brochure and some other handout materials.

These meetings are not intended to be the only means for us to learn of the concerns of members of your community. Other ways of expressing comments include (1) completing and returning the reply form which will be included with the document; (2) writing a personal letter; or (3) calling me or other Restoration Team members directly. At the conclusion of the series of meetings we will review all the public comments and consider them during development of the final Restoration Plan.

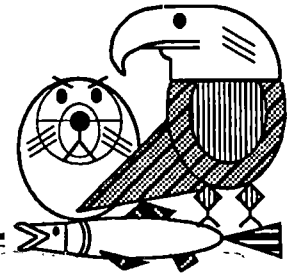

Symposium presenters to reveal oil spill studies

ANCHORAGE—In the first public discussions since the *Exxon Valdez* oil spill, hundreds of people will gather in Anchorage next month to hear the results of years of study on effects of the spill. Scientists will cover topics as varied as effects on herring larvae resulting in deformed and missing jawbones, nesting success and death of sea ducks and the deaths of thousands of sea otters.

Their findings will be made public at the *Exxon Valdez* Oil Spill Symposium, February 2-5 in Anchorage, Alaska. Presentations will be given each day of the symposium at the Egan Civic and Convention Center in downtown Anchorage.

The symposium will open with an all-day plenary session presented free of charge on Tuesday, February 2, beginning at 8:30 a.m. Alaska Governor Walter J. Hickel will deliver opening remarks. Dr. Richard Murphy, science and education vice president for the Cousteau Society, will give the keynote address. Plenary session speakers will follow with overviews of the spill, the ensuing cleanup, and the effects of the oil on the wildlife and ecology of Prince William Sound and the Gulf of Alaska. During the following three days, scientists will present detailed information about their findings in technical sessions.

The effects of oil on fish, birds, marine and terrestrial mammals, the marine environment, effects of cleanup and human impacts on subsistence and archaeological sites will be discussed. In all, 124 papers will be presented during the plenary, technical and poster sessions. A registration fee will be charged to attend the technical sessions Wednesday through Friday, February 3-5.

The Exxon Valdez Oil Spill Symposium is sponsored by the *Exxon Valdez* Oil Spill Trustee Council, the University of Alaska Fairbanks Sea Grant College Program, and the Alaska Chapter of the American Fisheries Society. The symposium is to be the first public discussions by scientists of injury assessment done in the wake of the spill, although the data and preliminary reports from many of the studies were released last summer.

"This information is important because we learned a great deal here that could be applied to other oil spills," said Bob Spies, chief scientist for the *Exxon Valdez* restoration programs. "We've had quite a bit of interest in the symposium from scientists in the Shetland Islands, Norway and other parts of the world. They're grappling with some of the same effects on organisms and ecosystems we've had to deal with."

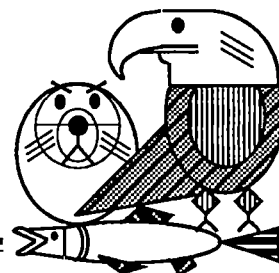
America's largest tanker spill occurred on March 24, 1989, when the *Exxon Valdez* ran aground on Bligh Reef and spilled nearly 11 million gallons of North Slope crude oil into Prince William Sound. More than 1,500 miles of Alaska coast were oiled in the spill that claimed the lives of thousands of birds, otters, and other wildlife.
