Around the first of April, the *Exxon Valdez* Oil Spill Restoration Team will be sending you a brochure that provides information about various restoration options. This document, a summary of the draft Restoration Plan, asks a number of questions and outlines strategies for the restoration of resources damaged by the March 24, 1989 *Exxon Valdez* oil spill, using funds obtained in the October 1991 settlement negotiated among the state and federal governments and Exxon.

We will be conducting a series of public meetings between April 12 to 30, 1993, to take comment from the public on reactions to the the information in this summary, to be used in preparing the final Restoration Plan. We need to know the best date, time and place to hold a meeting in your community so we can plan our travel schedule.


These meetings are not intended to be the only means for us to learn of the concerns of members of your community. Other ways of expressing comments include (1) completing and returning the reply form which will be included with the document; (2) writing a personal letter; or (3) calling me or other Restoration Team members directly. At the conclusion of the series of meetings we will review all the public comments. If necessary, we will then redefine the restoration strategies and generate alternatives that address those strategies for inclusion in the Restoration Plan.

We are currently putting together the schedule for this series of meetings, and it is important that you let us know your scheduling preferences as soon as possible. Please indicate in your reply the best dates during the period April 12 - 30 for the Restoration Team to come to your town, a place where we could hold the meeting, and the name of a contact person in your community that we can talk to in order to coordinate the meeting.
