





Enclosed is a draft agenda and a number of items for your review STRATIVE RECORD

The June 28 meeting has been scheduled for two purposes:

First, so we can update and brief you on a number of activities currently being undertaken by Trustee Council staff. These include updates on the Draft EIS for the Draft Restoration Plan, the Institute of Marine Science/Seward Infrastructure Improvements and Habitat Protection activities.

Second, the meeting is intended as a briefing on the status of the FY 95 Work Plan in order to assist us in developing the Draft Work Plan. Prior to this meeting, you will receive copies of all the project proposals received by our office that will receive technical review for possible inclusion in the Draft Work Plan, as well as a draft framework of the proposed work plan. Please be sure to review Chapter 3 and Appendix A in the <u>Invitation to Submit a Restoration Project for the FY 95 Work Plan</u> before the meeting (You have already been sent a copy under separate cover. Please call if you need another.). Your review of project proposals should focus on how well these proposed projects address the restoration priorities, goals and objectives discussed in Chapter 3 and Appendix A.

On August 1, we are tentatively scheduling an additional PAG meeting to review the preliminary Draft FY 95 Work Plan. The Trustee Council's review is tentatively scheduled for August 5. These meetings follow technical review by the Interim Science Review Board and the Executive Director. In order to accomodate this additional review, PAG members will receive the Draft Work Plan only a few days before the meeting. I apologize for this, but for this year's time schedule all review periods are extremely compressed. This will be corrected for FY 96

An additional PAG meeting will also be scheduled for early to mid-October to review the final Draft Work Plan and brief you on habitat acquisition and protection activities.

We realize this is a very tight review schedule. However, we are setting this up in order to provide you additional opportunities (two more than in past years) to provide input on development of the annual work plan. We look forward to your comments on that effort.




