

Dear Ms. McCammon:

On December 11, the Trustee Council authorized an additional \$100,000 for timber appraisal work on Tatitlek owned lands by Cascade Appraisal Services, Inc. (CASI) based upon an estimate we received in November 1995. Making the total estimated cost \$680,000. On December 20, 1995, we received a revised estimate of total cost of approximately \$830,000 (see enclosure). The new estimate is 45 percent higher than the original estimate (\$570,000) received for the work by CASI in June, 1995. The increase in cost is due primarily to two items. First, is the addition of acreages to be appraised around Bidarka Point, and Two Moon Bay after the first estimate of cost/acre was determined in June. Second, is the additional and more accurate aerial photographic work that was needed and completed which indicated a significantly greater acreage of standing timber. Much of this timber was originally thought to have been cut. The combined effect was that the acres needing timber appraisal work increased from 15,800 to 31,148 acres. We are requesting an additional \$150,000 to complete the timber appraisal work for Tatitlek land.

The result of this increased work load was a resulting increase in cost (\$250,000) and also, a lengthening of the time frame to complete the work. A new time frame verbally received from CASI on January 10th is mid-February. We will be requesting a written schedule for completion of the Tatitlek timber appraisal from CASI.

As we discussed by telephone on December 15, the current status and revised budget estimate for the Tatitlek project is a result of finding more timber on the property than originally projected. Our original estimate of the total number of cruise plots was  $\pm 3,950$  plots on a 4 chain by 10 chain grid. This would result in (1) plot per (4) acres over an estimated 15,457 timbered acres (see attached). The original estimate was based upon old photography and type maps provided by Tatitlek's consultant - Clare Doig. New aerial photography and on the ground work revealed a substantially greater number of acres of timber present on the Tatitlek lands, especially in the Two Moon Bay Area.

Actual field work resulted in the placement of 5,165 plots or 30.76% more plots than originally estimated. However, the grid was enlarged for the Two Moon Bay area to 8 chains by 20 chains or (1) plot per (16) acres This change in plot spacing was done to facilitate finishing the field work in 1995. Two Moon Bay had 874 plots placed upon its timbered area indicating a total acreage of 13,984 acres. Had we used the original spacing (4 ch x 10 ch), an additional 2,622 plots would have been required to cover the Two Moon Bay timbered acres. We feel the reduced coverage will be adequate statistically for Two Moon Bay since there is an existing harvesting history on this particular tract.

The remaining 4,291 plots were placed on all other areas of Tatitlek ownership, including Bidarka Point, utilizing the original 4 chain by 10 chain grid for an indication of 17,164 acres in those areas. The combined timbered acreage cruised will approximate 31,148 acres as compared to the original estimated 15,800 acres - an increase of 97.14%.

The net affect of an increase of this magnitude is an increase in overall estimated cost. We feel that the overall estimate will be about 45% higher than originally projected. The increase is a result of additional field work with its accompanying travel expenditures including helicopter, room and board, and commercial airline expense. Additional costs in the areas of cruise extension, mapping, and valuation will also be incurred.

The field work has been check cruised by Tatitlek consultants. The results of that check cruise, by cruiser, are attached for your review. We have made a rough calculation as to the effect of sort variances and find them to be negligible. Overall, the check cruise sampled 2.88% of the total number of cruise plots. The results show little variance  $(\pm 2\%)$  between the cruise and check cruise and no further sampling was deemed necessary.

We are presently mapping the property, laying-out harvesting plans, and proceeding with the appraisals. An individual appraisal of the timber owned by Citifor at Two Moon Bay, the timber which Citifor has a right of first refusal at Whalen Bay, the timber in the Hells Hole area which Citifor also has a right of first refusal, and the entire remaining Tatitlek ownership is presently scheduled. This should provide the valuation variables they will need to proceed with their negotiations. We expect to have the Whalen Bay and Hells Hole appraisals out by Christmas with the other (2) to follow shortly thereafter.



As the Public Policy Coordinator for the National Outdoor Leadership School I was involved in the 1995 Work Plan Project Proposal # 95002, the Leave No Trace Educational Program: Reducing Human Impact to Assist Long form Ecosystem Recovery. The three phases of the Leave No Trace Program for Frince William Sound were designed to reduce impacts of recreation users on recovering resources. The effect of increased and concentrated recreational use could be mitigated through education using common themes and valid research. The proposal was denied due to an inadequate link to restoration. Since the original funding request, NOLS and the US Forest Service have pursued other funding sources and there are no plans to resubmit the request to the Trustee Council in the future.
