Please note that, in some cases, individuals are being nominated as candidates eligible for more than one interest group seat.

I have been a resident of PWS/Alaska since 1987, having made my home in Cordova. I have held a herring pound permit since 1988 and a salmon drift permit since 1994. I own and operate my own fishing vessel and have participated in herring and salmon gillnet, seine and setnet operations beginning in 1988. I have also participated in the Bristol Bay salmon gillnet fishery in 1994.

Since 1990, I have been sales manager for Eyak Packing Co., a 15 year old custom smokehouse and cannery in Cordova. This is a mail order business for Copper River salmon products with customers worldwide.

In 1990 I was elected to represent the PWS herring pound fisheries on the board of Cordova District Fishermen United. I have served twice as vice president of the board and am currently serving my sixth term on the CDFU board. In this capacity I have represented PWS fishing interests in many venues including the Alaska state legislature, gear regulation negotiations with the ADFG, gear representative to the Board of Fish, co-chair of the PWS Fisheries Ecosystem Research Group in 1993-94, the PWS Economic Development Council, and United Fishermen of Alaska.

I am also serving my third year on KCHU-Valdez public radio board of directors as a regional representative.

From I991-I995, I did seasonal summer field work for the Alaska Department of Fish and Game. I was involved in a number of projects in PWS and along the Kuskoquim River and Bering Sea coast including herring and salmon test fishing and weir management projects, genetic data collecting, and stomach content analysis work.

My ten years involvement in commercial fishing has taken me into many facets of the industry. I feel that I bring a well rounded perspective to the Public Advisory Group and would like the opportunity to contribute to EVOS programs and goals over the next 2 years. EVOS programs have had a very large impact on PWS and the entire spill impacted region and there is still much prioritizing and work which needs to be done.

Dear Ms. McCammon,

This letter follows my October 31 response to your call for applications to serve on the Oil Spill Public Advisory Group. I would be honored to serve on the PAG, and have enclosed my resume for your consideration. I believe the work of the PAG and the Trustee Council is very important, both for its direct impact on the restoration of the spill area, and through this effort, its contribution to the state's economic health and quality of life. I also have a particular fondness for Prince William Sound and the coasts of Kenai, Kodiak and Southwest Alaska. I think this area, which I've visited by plane, boat, skis and kayak, is among the most remarkable in Alaska.

I believe my 15 years experience in land planning, resource management and socio-economic analysis would make me a valuable member of the PAG. Particular skills I can offer to the Public Advisory Group are listed below:

Regional Environmental Planning - I have extensive experience in natural resource and environmental planning, which will help me better respond to issues related to the effects of the spill on resources and services. I'm very interested in the natural sciences and actually enjoy reading and discussing technical material that many people might find a bit dry.

Land Planning/Real Estate Development - Over the last 7 years, I've worked in land planning and real estate development. I have gained a strong understanding of the design, financial and political processes required to get houses, stores, roads, parks, stream restoration projects, etc. developed and paid for.

Tourism and Recreation - Much of my recent work in Alaska has focused on tourism and recreation, which gives me a strong base of knowledge about trends in resident and visitor recreation activity throughout the state, including the oil spill area.

Project and Budget Management - Throughout my career I've been responsible for guiding large scale, complicated planning processes. I have developed and implemented clear responses to middy, complex problems, and become skilled at setting budget priorities and policy direction amid competing public and private objectives. I've also worked extensively with public groups on planning and resource management issues.

I am seeking this position on the PAG as a general public, "at-large" member, without a link to a specific interest group. My intent would be to participate from a perspective that, I believe, represents the views of many Alaskans. This perspective is based on the recognition that the state is entering a time of profound

challenges, and that there is a resultant need for both great vigor and great care in how we manage the state's resources, both natural and financial, to create a more sustainable economy and a better place to live and visit.

I returned to Alaska last fall after a seven year absence. It's great to be back but I feel a real urgency to try to contribute to solving the many challenges I see facing the state. The restoration of the spill area's fish and wildlife populations, their habitat and associated human uses would be a satisfying context in which to work on these goals.



Dear Trustee Council members:

My first involvement with the *Exxon Valdez* oil spill was as a citizen volunteer, working in the animal rescue centers in Valdez in the days and weeks immediately following the accident. I would like to return to that citizen volunteer role in service to the Trustee Council and the citizens of Alaska and the spill-affected communities, as a Public At Large representative on the Public Advisory Group.

During the early days of spill response and cleanup, through the damage assessment and then restoration phases of response to the oil spill. I have had the privilege and honor to come to know a great many people in the communities affected by the spill. Either through personal visits or on official business. I have spent time in almost all of the affected communities, including Akhiok, Chenega, Chignik Bay, Chignik Lagoon, Homer, Karluk, Kenai, Kodiak, Larsen Bay, Old Harbor, Ouzinkie, Port Lions, Seldovia, Tatitlek, Seward, Whittier and of course Valdez, where my husband and I were living and working at the time of the spill. The only affected communities I've never visited are Nanwalek, Port Graham, Perryville and Ivanof Bay, though I've spoken with people from each of those places. On numerous occasions I worked closely with local residents and officials to organize public meetings, to disseminate information to citizens and to solicit their comments on a variety of documents and subjects relating to response and restoration. Through this process I've had the good fortune to make many friends throughout the region. I've listened to people's concerns, answered many of their questions, and passed on information about the issues that were important to the citizens of the area to state and federal agencies, and to the Trustee Council. I have friends and acquaintances who work or have strong interest in each of the twelve principal interests represented on the Public Advisory Group, and we have discussed their concerns and their priorities on many occasions.

I've discussed the idea of my serving on the PAG with some past members, including Pam Brodie and John French. In all cases the response has been strong encouragement.

I feel that I have a unique contribution to offer to the Public Advisory Group and to the Trustee Council because of my involvement with the spill since the very day of its occurrence. Although I've never been in a role to *make* policy decisions, I have served as a conduit to carry information and opinions about policies and recommendations back and forth to the citizens and to the agencies involved. In the process I've learned a great deal about the concerns and priorities of both. I offer to the citizens of the spill region and to the Trustee Council the knowledge and experience I've gained in the hope that I might be able to use that knowledge to continue to serve in a useful capacity.







Dr. French is a twelve year resident of Alaska, and a seven year resident of Koliak. MSC. He owns houses in Kodiak and Homer and has conducted research projects in Prince William Sound, Cook Inlet and the Kodiak archipelago. He is a Professor of Seafood Biochemistry and Interim Director of the University of Alaska Fairbanks' Fishery Industrial Technology Center (FITC) in Kodiak. In this capacity he works with fishermen and seafood processors throughout Alaska. The FITC conducts research, training and technology transfer activities in fish harvesting and seafood processing science and technology. Directly or indirectly, this industry effects the lives of most people living in the area effected by the Exon Valdez oil spill. During the oil spill Dr. French worked with fishing organizations, processors, National Marine Fisheries Service, Alaska Departments of Fish and Game and Environmental Conservation to develop rational management strategies for fisheries (especially salmon) in the spill effected area.

Dr. French's academic and research training and experience is a very unusual combination of biochemistry, biochemical toxicology, fisheries and food science. As such he brings a unique perspective to many of events which occurred during and in the three years since the oil spill. His original research on the structural organization of the liver enzyme system which is responsible for the initial metabolism of hydrocarbons has gained international recognition. More recently he has studied the hydrocarbon metabolizing systems in Pacific Salmon, including a comparative study of sockeye salmon from different geographical areas, including Prince William Sound. His current studies on seafood include evaluating the effects of environmental variation on seafood quality and safety.

Since all commercial fisheries which were threatened with potential tainting of products by the spilled oil were closed (salmon and herring fisheries), Dr. French's efforts were concentrated on subsistence foods and assistance to local organizations and government. He coordinated work with Alaska Department of Fish and Game, Subsistence Division and Kodiak area communities to collect samples of subsistence foods from traditional use areas. He was appointed to the national Toxicological Experts Panel for Evaluation of subsistence foods from the oil spill area. This committee provided advice to the State Epidemiologist, the Oil Spill Health Task Force, and NOAA. It also produced a set of recommendations for response to future oil spills. Dr. French often represented the FITC on the Kodiak Island Borough oil spill response group. In this role he developed and presented information on such issues as clean up methods, effects of temperature on oil composition, or bioremediation agents. He continues to serve on the Borough advisory group.

Dr. French directed a number of small, unfunded research activities to assess the scope of the oil spill. The only NRDA project he worked on was part of the large Coastal Habitat study the University of Alaska Fairbanks, School of Fisheries and Ocean Sciences did under contract with the U.S. Forest Service. This subtask helped assess the impacts of

Crude oil exposure on intertidal fish.







As a nominee to the Exxon Valdez Oil Spill Public Advisory Group this is my response to your letter of 7/21/92 regarding possible conflicts of interest.

For question three, I am employed on an intermittent basis by the US Fish and Wildlife Service (USFWS) and by Alaska Biological Research Inc. (ABR), both organizations that have been involved in oil spill related studies in Prince William Sound and might possibly be in the future.

I retired from USFWS in 1983 after some 33 years involved with bird studies in Alaska. I receive an annuity based on about half-my former salary. Since that time I have remained active in Alaskan bird studies on a part time basis.

In 1984 I was given a permanent position with USFWS as a "rehired annuitant". This means that I can be employed for short term projects without filling out additional employment forms. My pay is based on my pre-retirement grade minus the amount of my annuity, calculated on a daily basis. I have averaged about a months work per year for USFWS.

During the same period I have averaged about a months work per year for ABR mostly doing aerial bird surveys.

I did not work on any Oil Spill projects.

I have also done some small projects for LGL Inc. ARCO Alaska Inc. and Coeur Alaska Inc.

These projects while providing a little handy cash, are not my primary source of income. The primary purpose is to stay current on the crnithological scene in Alaska as I have been doing for more than forty years. I am not interested in any great increase in employment.



It is not just Chuck's oil spill experience which makes him valuable as a PAG member. He has a long history of involvement with the commercial fisheries of this area and Alaska, enjoying a long and profitable career with ADF&G and for the past two years as a fisheries consultant. In particular, he was the regional research biologist for the Commercial Fisheries Division immediately prior to joining the spill effort and has the capacity to professionally critique many of the proposed projects upon which the PAG makes recommendations to the Trustee Council.



### Assessment Recommendations Approved by Council

On October 3, the Coastal Policy Council acted on 30 recommendations to alter and improve the ACMP. This Council action represents a milestone for the ACMP Assessment. As Jeff Bush, Deputy Commissioner of Commerce and Economic Development notes, "It is very exciting to see the Assessment project coming together after many complex and controversial questions have been debated and carefully analyzed." "The recommendations of the Council represent the culmination of a year and a half of dedicated work by a lot of people," adds Scott Novak, Council member from Cordova.

Some of the recommendations will lead to statutory and regulatory changes; others will spur administrative action and good will on program changes. "I am optimistic that these changes will bring us the balance and efficiency that we are seeking for our coastal program," remarks Scott Novak. "And equally significant," adds Jeff Bush, "I believe this process, involving all interested parties, has reopened communication and trust between the state, local districts and municipalities, potential developers, and affected citizens."

Council discussion highlighted the critical role that the enforceable policies guidelines will play in improving coastal district plans which are the building blocks of the ACMP.

Several Council members viewed the recommendations relating to plan improvements as the core of all the Assessment recommendations. In fact, the Council expanded the plan improvement recommendations by including the plan requirement suggestions advanced by the Department of Community and Regional Affairs. (See related article on page 5.)

Several Assessment recommendations focused on expanding the voice range of the coastal districts through "local knowledge" and "public need." Recommendations directing statutory changes will allow districts to delegate ACMP planning and implementation similar to that allowed under Title 29 and clarify responsibilities and relationships among boroughs, CRSAs and cities. The Council action also directed the Municipal District Committee to consider new approaches for districts to decide consistency on local projects.

The recommendations relating to streamlining petitions and elevations received considerable attention by the Council. After much discussion, the Council opted not to eliminate "B1" petitions at this time. Instead, they directed staff to examine petitions in the context of eliminating appeal redundancy or duplication across parallel processes of state resource agencies and associated statutes. After moving to accept the recommendations relating to program enforcement, the Council formally approved the Assessment recommendations by adopting Resolution 96-1 (see page 2).

THEREFORE, BE IT RESOLVED, that the Alaska Coastal Policy Council accepts the recommendations contained in the report, Coastal Policy Council Report on the ACMP Assessment as modified by Council action on October 3, 1996, and directs the Division of Governmental Coordination to proceed with appropriate actions, including legislative and regulatory drafting for implementing these recommendations.


I do not have any interest in property which has been proposed for acquisition by the Trustee Council, nor does any family member or relative.



#### KNOWLEDGE OF THE AFFECTED REGION

Charles W. Totemoff lived in Chenega Bay from 1983 through 1992. Seven years ago the *Exxon Valdez* Oil Spill drastically altered his lifestyle. Rather than take a passive role throughout the Oil Spill clean-up and restoration activities, Mr. Totemoff opted for involvement. He coordinated clean-up efforts in and around Western Prince William Sound. Mr. Totemoff has also participated and continues to participate on various committees and organizations formed during the response effort.

Mr. Totemoff possesses a unique understanding of the spill affected regions. He has coordinated scientific research and spill related activities and continues to work with other spill affected communities to involve them in the restoration effort.

# KNOWLEDGE OF THE AFFECTED PEOPLES AND ECONOMIC AND SOCIAL ACTIVITIES OF THE AFFECTED AREAS

Chenega peoples are historically resource dependent peoples. They hunt, fish, trap and gather foodstuffs from the waters and lands around their village. Since the Oil Spill, the subsistence way of life has changed dramatically for those villages in spill affected regions. Hunting and fishing takes place forty to fifty miles from home. This great distance takes the people away from the villages to areas thought to be free from contamination.

However, the suspicion of contamination is still high. The Native people know the migratory habitats of all the animals. They fear eating contaminated resources. The habits of the people are not as communal anymore as there are fewer resources available to share. There are also limited opportunities for teaching or passing on of traditional knowledge of food gathering or preparation when most of this activity takes place further away from the villages.

Charles W. Totemoff has direct experience with the changes in the economic and social activities caused by the Oil Spill in the affected regions and his ability to communicate this experience to those outside his village is invaluable. His personal experience with the families of his community and interaction with members of other heavily impacted villages have greatly contributed to his knowledge of the effects that the Spill has had on the affected peoples, economies and social activities.

# CHARLES W. TOTEMOFF RELATIONSHIP AND INVOLVEMENT WITH PUBLIC ADVISORY GROUP PRINCIPAL INTERESTS

#### NATIVE LANDOWNERS

As a life-long rural Alaska resident, Charles W. Totemoff has had extensive experience in Native land ownership. Mr. Totemoff is a respected member of the Native community and is well suited to accurately and fairly represent the vital interests of the Native landowner on the Exxon Oil Spill Public Advisory Group.

#### **FOREST PRODUCTS**

• Chenega Corporation is a primary timber holder in the spill affected area and is also one of the owner-villages of Koncor Forest Products Company. Mr. Totemoff has had intensive involvement with Alaska's forest products industry through corporate timber ownership and his present position as a Board of Director of Koncor Forest Products.

#### **COMMERCIAL FISHING**

Many Chenega villagers rely on commercial fishing as the primary source of their income. As the Oil Spill had such a direct impact on the ability to commercially fish and on the areas available to fish, Mr. Totemoff has had an opportunity to experience directly the effects of the Oil Spill on the commercial fishing industry. Charles W. Totemoff has also commercially fished in Prince William Sound during his ten years of living there.

#### **CONSERVATION**

Charles W. Totemoff's cultural beliefs include the belief that there are diverse groups of peoples that live in Alaska that are separated by culture, traditions and lifestyles. However, for hundreds of years these peoples have lived in balance with Nature in a caretaker fashion. There is a respect by the peoples for their environment. Conservation of Alaska's environmental resources is a vital part of this belief.

#### LOCAL GOVERNMENT

Charles Totemoff moved to Chenega Bay in 1983, prior to the village rebuilding where he worked with various agencies on the development of the new community. He has served as the tribal administrator and chairman for the Chenega Bay IRA Council. Additionally, he has helped coordinate master plans for development for the village of Chenega Bay.

As President and C.E.O. of Chenega Corporation, Mr. Totemoff is intimately involved with a locally-run and locally-elected governmental body. He serves as President of Chenega Corporation and has served as the Chairman of the Chenega Bay IRA Council.

#### **ENVIRONMENTAL**

Charles W. Totemoff was responsible for the Chenega Bay response effort during the *Exxon Valdez* Oil Spill clean-up. Also, through his positions as Corporation President and C.E.O. and IRA Council Chairman, Mr. Totemoff has participated in bio-remediation programs and scientific testing on oiled lands.

#### **SUBSISTENCE**

Chenega peoples are historically resource dependent peoples. They hunt, fish, trap and gather food from the waters and lands around their village. Since the Oil Spill, the subsistence way of life has changed dramatically for Chenega Bay and many other villages. Charles Totemoff's direct involvement with Native community members who rely on a predominantly subsistence lifestyle is invaluable experience that can be acquired only by a person who is a part of that lifestyle.

#### SCIENCE/ACADEMIC

As President & C.E.O. of Chenega Corporation, Charles W. Totemoff has helped with spill clean-up, bio-remediation programs and scientific testing on oiled lands. He has extensive experience in working with Federal, State and private sector scientists and academic advisors.

# NATIVE LANDOWNERS PRINCIPAL INTEREST NOMINEE CHARLES W. TOTEMOFF CONTRIBUTION STATEMENT

#### LIFETIME NATIVE LANDOWNER EXPERIENCE

It seems all too often that decisions are made <u>for</u> Alaska's Native landowners who were affected by the spill rather than <u>with</u> them. Charles W. Totemoff brings a lifetime of Alaskan Native landowner experience as well as recent "hands-on" experience of the spill from cleanup to subsistence to planning for the future. His wealth of knowledge and ability to communicate and cooperate with other spill affected landowners will be a tremendous asset to the Public Advisory Group. Mr. Totemoff brings to the Trustee Council an opportunity to hear directly from those people who were and remain the most severely impacted by the spill.

#### **DIRECT AND ON-GOING EXPERIENCE WITH SPILL AFFECTED AREAS**

Chenega Bay was one of the most severely impacted areas of the spill. Evidence of the spill remains on the beaches and perhaps most importantly, in the minds and hearts of their people. As a member of Chenega Corporation, Mr. Totemoff has been an instrumental participant in the study and restoration of these spill affected areas. Mr. Totemoff will bring the ability to experience first-hand exactly how the spill has impacted and continues to impact the Native landowners of Alaska.

#### AN ALASKAN NATIVE PERSPECTIVE

It is essential that the Public Advisory Group continue to have representation from the Native community. An Alaskan Native perspective, especially a perspective from a spill impacted area, gives the Trustee Council and the Public Advisory Group an inside understanding of how the Native people view their lands. With much discussion centering around possible Native land acquisition, a person with the ability to represent these landowners becomes critical. It is hoped that Mr. Totemoff will be again be selected as that person.

#### **CHARLES W. TOTEMOFF CONFLICT OF INTEREST STATEMENT**

Do you, your spouse, children, any relative with whom you live or your employer have or are you defending, a claim filed before any court or administrative tribunal based upon damages caused by the Exxon Valdez oil spill? Yes. Charles W. Totemoff is a member of the class of Natives who have sued Exxon Corporation and related defendants in Federal District Court. That action was recently settled in the approximate amount of \$20 million. Charles W. Totemoff's employer, Chenega Corporation, also has an action for damages caused on account of the Exxon Valdez Oil Spill pending in Alaska Superior Court.

Do you, your spouse, children, any relative with whom you live or your employer own any property or interest in property which has been, or is likely to be, proposed for acquisition by the Trustee Council? Yes. Chenega Corporation, the employer of Mr. Totemoff, is presently negotiating with the United States Forest Service and the Exxon Valdez Oil Spill Trustee Council for the sale of property and interests in property.

Have you, your spouse, children, any relative with whom you live or your employer submitted, or likely will submit, a proposal for funding by the Trustee Council? Yes. Charles W. Totemoff's employer, Chenega Corporation has recently proposed a beach treatment project with AEDC which was funded by the Trustee Council. I was Born September 7, 1948 in Kodiak and raised first 7 years of on Afognak Island in a logging camp owned by my father. That logging operation with associated sawmill and planner was washed away in the Good Friday earthquake and tsunami of 1964. I spent the Summers from the time I was 6 years old till I left for college commercial salmon and crab fishing around Afognak and Kodiak Island. Graduated from Kodiak High School in Kodiak and attended one year of college before joining the Navy in 1968. Spent 2 years in Japan of which 6 months were spent in Vietnam. After the service spent one and a half years with father starting a logging operation on Afognak Island, at location of previous logging and sawmill operation. Managed and operated virtually all phases of operation from road building to scaling and rafting. Worked as operating engineer from 1973 to summer of 1975 on road projects in Kodiak and in Valdez working on road to terminal and the pipe yard for the Alaska Pipeline. After that went to flight school and completed private, instrument, commercial, float, multi-engine land, and flight instructor ratings. Then flew commercially from 1977 through 1988 racking up about 8,000 hours in Anchorage, McGrath, and Kodiak Island areas. From October of 1988 through June of 1996 worked full time for Afognak Native Corporation as lands manager, systems manager, and directly involved in Timber Sales, Inventory control, and as a Director of Afognak Native Corporation from 1982 to present. I am a native shareholder in the Koniag Regional Corporation and of Afognak Native Corporation. I am the chairman of the planning and zoning committee for Afognak Native Corporation and have been Chairman since April of 1985 of the Afognak Joint Venture, which is currently in negotiations with the EVOS Trustees for the acquisition of a portion of its land. I am currently the Chairman and Chief Operating Officer of the Afognak Joint Venture.

Spent various times King Crab fishing around Kodiak Island as I grew up and 1978-1980 fished full

time, year around, around Kodiak Island and from Swishak to Castle Cape, South of Chignik. Spring of 1973 spent Tanner Crab fishing out of Cordova around Hinchinbrook Island and harvesting herring row from kelp. From May of 1980 - October 1988 flew commercially out of Kodiak to all villages in the Kodiak Archipelago and also hunters into remote areas around Afognak and Kodiak Island. Also owned my own supercub from 1978 through 1985 which I used to go hunting and fishing around Afognak and Kodiak during free time and herring spotting in the Togiak Fishery.
