Re: Afognak Joint Venture Offer

Dear Ms. McCammon:

The Afognak Joint Venture rejects the proposal tendered by you and Alex Swiderski on March 9, 1998. It is counterproductive to our efforts to reach agreement on sale of AJV lands. We have consistently explained that any transaction must include both a reasonable ratio of commercial to non-commercial lands and a justifiable return on AJV's timber resources. Their March 9 proposal includes neither. By our calculation, land values in the March 9 proposal made up only 7% of the total package value, resulting in a land value of about \$75 per acre.

For the past 5 years the AJV has patiently negotiated openly, fairly, and in good faith with the Trustees' representatives. At their request the AJV has deferred logging some of its most valuable lands during peak markets. In turn, the March 9 proposal would cherry-pick valuable commercial and recreational components of AJV's lands and value those assets based on temporarily depressed timber prices. The appraisal upon which the Trustees rely places values on our timber below levels we actually realize from our own operations and contains a "profit and risk" discount which assumes AJV profits transfer to EVOS. Even during timber market peaks in 1993 and 1994 AJV made it clear that it would not sell valuable commercial lands in a stand alone manner. AJV most certainly will not do so now at lower price and under compulsion to forgo its profit factor. The AJV representatives are accustomed to the peaks and valleys of timber markets and know that, historically, patience in down cycles is rewarded by succeeding peaks that exceed prior levels.

Last Monday, the AJV proposed a creatively configured package that met the Trustees' priorities and still met AJV's requirements. In doing so, AJV made substantial accommodations both in value and in the addition of high priority timber and recreational land. It was a well-considered bottom line proposal which AJV expected to be well-received. The Trustees' March 9 response was surprising and, frankly, considered by some AJV representatives to be an affront to their prudent business judgments and fiduciary duties to shareholders.

Not knowing whether the March 9 proposal was merely a negotiating strategy or whether some unstated financial limits may genuinely restrain the Trustees, and in a last effort to find something that will work, the AJV representatives have been persuaded to make three alternative offers. Each represents a different magnitude of transaction. Each offer expires as of 6:00 p.m. on March 20, 1998, unless earlier withdrawn by AJV. The alternatives are summarized below. They are described in more detail in the attachments. All prices listed are net present value. Delayed payments must include appropriate interest.

Alternative 1: This is the largest alternative. It is similar to our offer of March 9 except that subunit F has been removed and the price adjusted accordingly. AJV offers to sell these lands for \$75,268,000.

Alternative 2: This second alternative attempts to meet the Trustees' preferred configuration by removing lands from unit 4 and reducing the overall price of the transaction. However, to do so and maintain balance of valuable commercial and recreational property with other AJV habitat lands, AJV has also removed about one quarter of the timber from unit 3a, removed the Blue Fox Bay islands, and adjusted the value accordingly. AJV is willing to defer harvest in subunits J, M, C, L and O for two years during which time it is willing to trade them for timber of equal value in Seal Bay State Park. AJV offers to sell these lands for \$64,540,000.

Alternative 3: The third proposal consists of units 1a, 7, and 8. AJV offers to sell these lands for \$43,239,000.

The offers are subject to the approval of the AJV Board and terms of the AJV Agreement. However, they have been reviewed and approved by the AJV Executive Committee. Each of the above alternatives is a total package, and components of one alternative may not be added to another without AJV's agreement. After March 20, 1998, AJV will submit its 1998 harvest plans to the Division of Forestry and will, without further deferrals, commercially develop its lands in the time frames and manner most suited to maximizing the resource values. AJV presently plans to commence 1998 logging operations in April.

If the Trustees accept any of the above alternatives, please respond by the close of business, March 20, 1998.

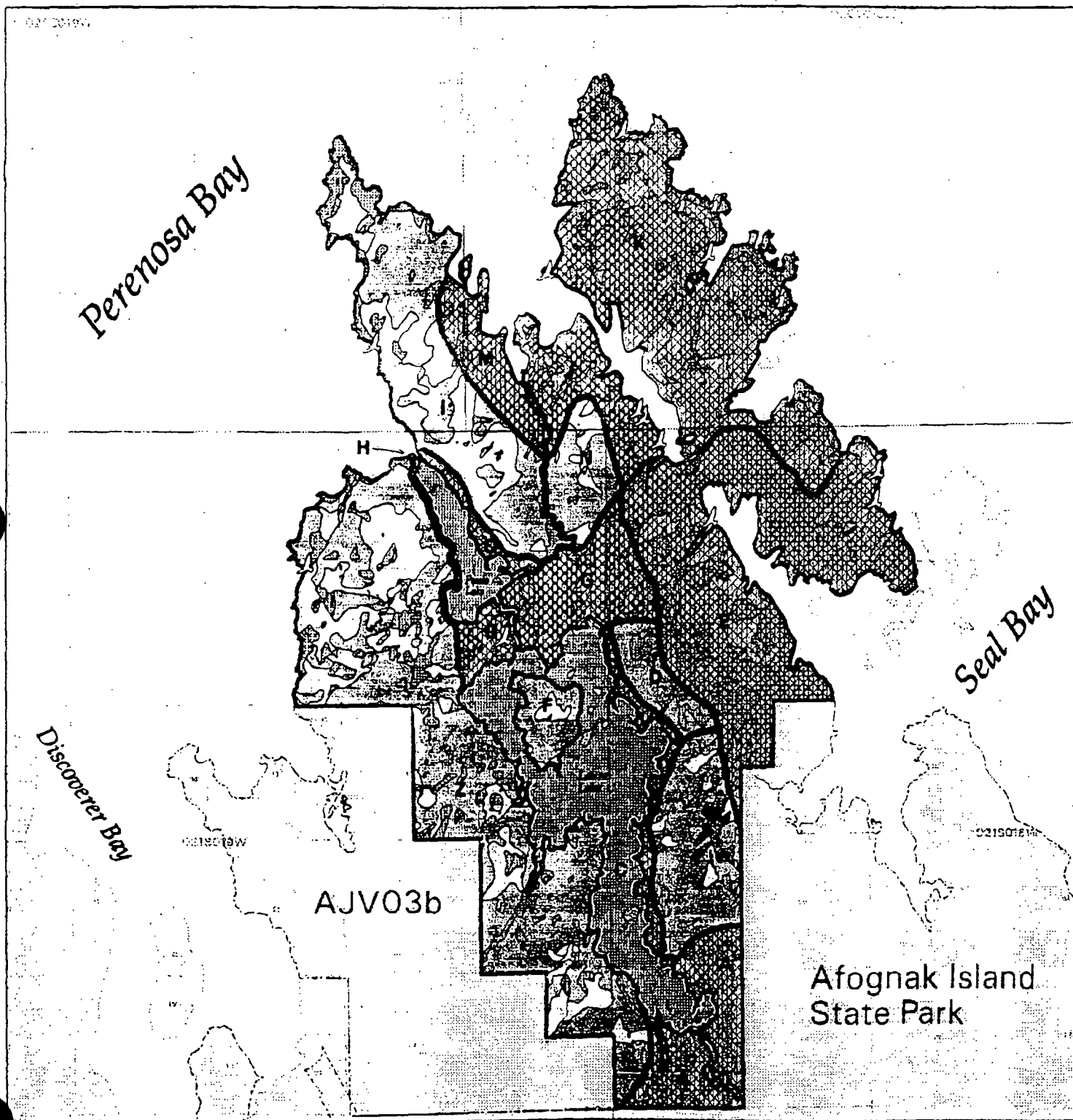

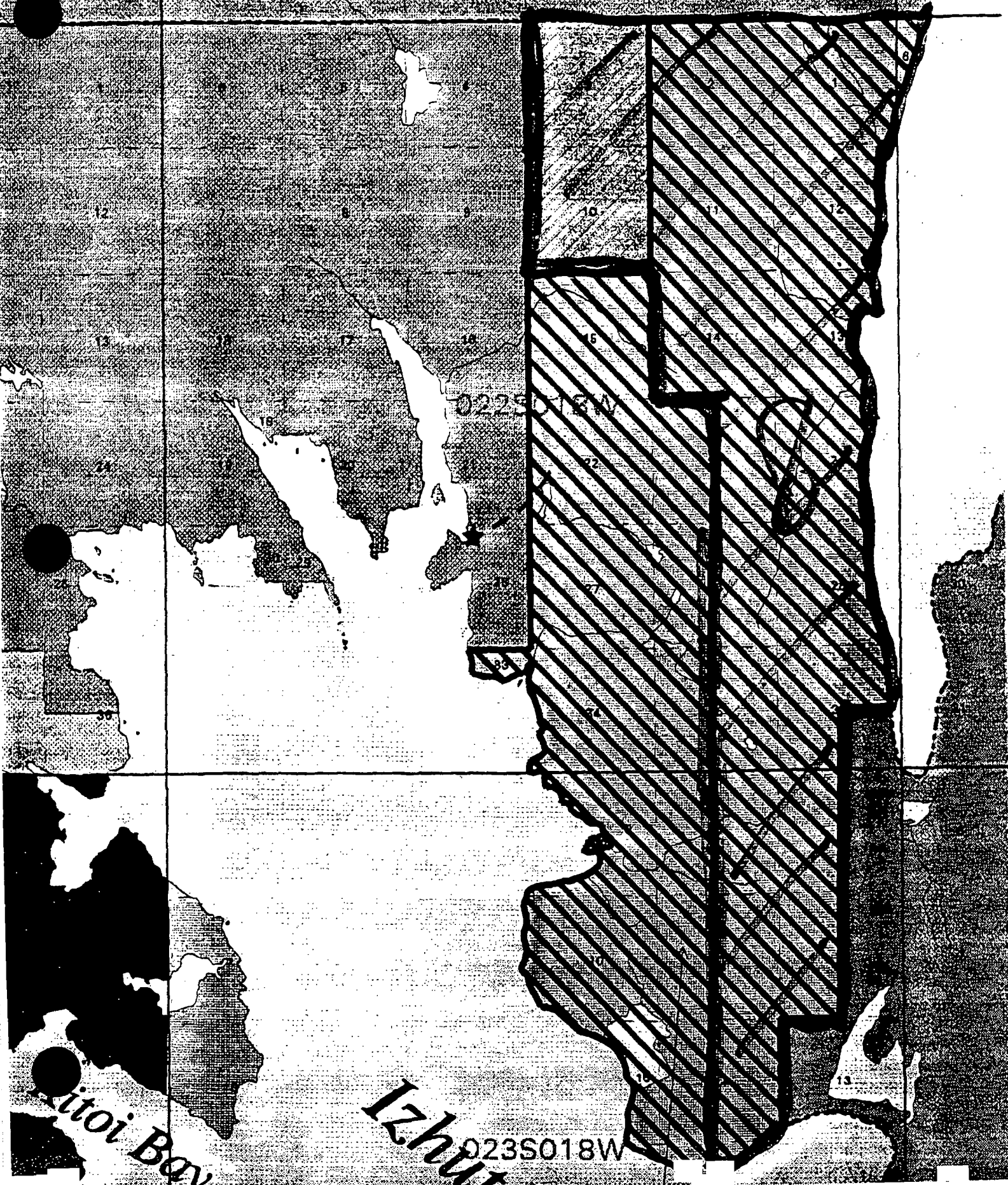
High Ranking Parcels
