Thanks for looking over the survey plan. The list of sites is guaranteed to expand considerably, as the Trustee Council voted to include the sites requested by Chenege Bay. We have been reviewing the list of 82 Chenega Bay requested sites to ascertain the most recent oiling data from those sites, set priority for survey, and arrange the logistics. This has been a formidable task, as the Chenega Bay list more than doubles the list in the plan. In addition, I've been asked to contact Kodiak island communities to try and pin down the areas that local residents say contain persistent oiling.

All this means that the project is expanding as the summer contracts. The first cruise, beginning this weekend, comes earlier than we thought but it's important we hustle out there. Thanks for your help in getting this moving within the short time frame we have.

The first phase is June 19-27. We have blocked out the first two weeks of July for helicopter surveys at sites out of the general survey area, such as the handful of sites in the Gulf of Alska at the tip of the Kenai Peninsula (Tonsina, Chugach, and Windy Bays). The next vessel cruise is July 15-25, followed by a quick turnaround and return to the field August 1-10. We moved the first August survey up a bit so we could work another cruise in during that month, probably Aug. 26-Sept. 3, give or take a few days either way.

Here is the schedule for the June cruise.

The vessel sleeps 10-12 comfortably, but it look like there will be fewer than that on this cruise. There are two heads, with showers, and the vessel has a water maker. There is ample plug-in space for computers, etc. in the lounge-kitchen area. The after deck is covered and enclosed and ca be heated. There is a VCR and tape deck in the lounge. The vessel owner has chartered for a number of scientific cruises and knows generally what kind of setting, work space, etc. is necessary.

Marianne Profita of ADEC will be the team leader for this cruise. She will have data packets for all participants and will conduct a short briefing during the run from Seward up into the Sound. Marianne has logged a tremendous amount of field time since 1989 and has a reputation for working well in a multijurisdictional setting. This is jargon for the fact that she's knowledgeable, decent, and considerate.

There will be air support on this cruise and all the others. A Beaver will be meeting up with the Pacific Star on June 23 to drop off several people for a couple of days (ADF&G, ADNR, me, and any others who want to go out overnight). The float plane will pickup the overnight passengers on June 24.

I will be making a radio check each morning, and possibly each evening, from the ADEC spill response radio base at Fort Richardson.

Again, thanks for your help in getting this going quickly.

A few reminders to the Restoration Team regarding the 1993 shoreline survey:

- 1. If anyone has any special permitting requirements, mitigation measures, etc., for this season, please let me know ASAP.
- 2. If you plan to have an agency representative on the upcoming shoreline survey June 20-26, please let me know as soon as possible who that person is. We need to make sure we get the right safety equipment, etc., to them, and make sure everyone understands the survey procedures on the shorelines.
