Dear Jim,

Thank you for your recent letter and your expression of support in my new capacity as Executive Director. In turn, I would like to say that I feel you have made a substantial contribution to the public input process as a public-at-large representative on the Public Advisory Group.

I wanted to also take this opportunity to respond to the concern you expressed in your letter regarding public involvement in the development of the Trustee Council's habitat protection and acquisition program. I feel that the record reflects extensive involvement by the general public and the PAG in the formulation of the Trustee Council's habitat protection program. More specifically:

- the *Restoration Framework Supplement* (July 1992) was subject to public comment on the essential conceptual framework for the habitat evaluation and protection process;
- initial development of the detailed methodology for the habitat evaluation and protection process was again subject to public review as part of the *Opportunities for Habitat Protection/Acquisition* document prepared in February 1993;
- the Supplement to the Draft Restoration Plan Summary of Alternatives (June 1993) was also subject to public review as well as the "newspaper" version that was widely distributed in April 1993;
- comment received from more than 2,000 individuals in response to the solicitation for comment on the *Draft Restoration Plan* indicated extraordinary public support for habitat protection with more than 90% of the people who responded indicating that habitat protection and acquisition should be part of the restoration effort;

Trustee Agencies

- the two-volume, *Comprehensive Habitat Protection Process: Large Parcel Evaluation and Ranking* (November 1993) was also subject to public review and invited comment on the specific information provided on each of the more than 80 individual large parcels that had been evaluated and ranked by the Habitat Work Group;
- the *Draft Environmental Impact Statement* (June 1994) on the draft restoration plan (that identified Alternative #5 as the Proposed Action with a range of \$295 325 million in potential expenditures on habitat protection) was also the subject of public comment this comment again reflected broad support for habitat protection and acquisition;
- in addition to these various public comment opportunities, the Public Advisory Group has been informed of the habitat protection and acquisition effort through briefings at a number of their meetings;
- the PAG approved an "Approach to Restoration Resolution" in July 1993 that specifically recognized the need to "protect habitat critical to resources injured by the oil spill or threatened by potentially injurious actions"; and
- in August 1994, the Trustee Council staff worked with the PAG to help develop the Trustee Council's "less than fee" and "public access" negotiation policy guidelines.

I think this brief summary and review of the many different public review and comment opportunities demonstrates that there has been substantial PAG and general public involvement in the Trustee Council's habitat protection and acquisition program. While there will always be debate and disagreement regarding the appropriate emphasis one part of the restoration program should enjoy (e.g., research vs. habitat protection), I believe the record clearly reflects extensive public involvement in the development of the Trustee Council's comprehensive and balanced approach to restoration.


Again, I appreciate your contribution to this effort and I wish you success in your future endeavors.



Dear Public Advisory Group Members,

EXACH VALDEZ OH. SPILL TRUSTEE COUNCIL ADMINISTRATIVE RECORD

Kenai Fjords National Park needs your help. We are entering a critical time period where the long-term fate of the park may be decided. As you are aware, approximately 77,000 acres, representing over 60% of the coast of the park, are scheduled to be conveyed to Nanwalek and Port Graham Native Corporations in the near future. Both Corporations have indicated a willingness to sell their interests in much of the land to the National Park Service to be retained in the park. Until recently the park service has not had access to funds that could be used for these acquisitions.

Recently the Department of Commerce announced that \$25 million dollars of the Federal criminal restitution funds resulting from settlement of the 1989 Exxon Valdez oil spill would be made available for purchase of lands affected by the spill. We understand the selected lands within Kenai Fjords National Park have very high priority for acquisition by the Federal Trustees. This is our opportunity to begin to make the park whole and provide a measure of restitution for oil-damaged parklands and villages.

Last year more than 108,000 people came to Seward to visit the park. A recent visitor survey showed that the average two-person visitor group spends \$215.00 a day while here on a variety of services such as food, lodging, gas, and recreation.

All day charter boat tours to the fjords served over 47,000 visitors in 1992 at an average cost of \$90.00 per person. The very areas that are under selection in the fjords are also some of the most visible and popular lands in the park. The park not only helps to make Seward a nice place to live. It also provides a significant boost to the local economy!

A letter from you to one or all of the people on the attached list would do much to support acquisition of these lands. Please help to keep Kenai Fjords National Park the spectacular world class area it is now. We can all be winners in this venture!



The Trustee Council approved the appointment of alternates to Public Advisory Group (PAG) members, pending amendment of the PAG Charter. The Charter amendment process has been initiated and will be completed when the Secretary of the Interior has signed and filed the amended Charter. Until that process is completed, alternates will not have voting rights.

To obtain Trustee Council approval of an alternate (which then goes to the Trustees and the Secretary of the Interior for official appointment), a PAG member must submit a packet of information about the nominated alternate. Some PAG members have already submitted some of this information (see attached status list, noting what information we already have). If any PAG member wishes to designate an alternate who will have full responsibilities at a meeting when the PAG member is absent, they must have the nominated alternate complete the information packet and answer the conflict of interest questions, as identified in the attached procedures. This should be submitted to Doug Mutter (at Department of the Interior, 1689 C Street Room 119, Anchorage, AK 99501) by Friday, April 23, 1993, in order to be incorporated into a package for consideration by the Trustee Council at their next meeting.

Please include the alternate's name, address, telephone number and social security number (for use only by the Designated Federal Officer in approving travel).

Procedure for Designation of an Alternate

Public Advisory Group members may recommend an alternate for their position. All alternates must be approved by the Trustee Council. The information described below should be submitted to the Trustee Council. From these nominations, the Trustee Council may select a designated alternate for each member or the Trustee Council may request additional nominations. The Trustee Council will forward their recommendations to the Trustees. Following approval by the Trustees, the Secretary of the Interior will officially appoint those alternates approved by the Trustees. When appointed, alternates may substitute for the official Public Advisory Group member at a particular meeting and will have all the responsibilities of the member they represent.

The information requested below shall be prepared by the nominee for alternate and submitted by the Public Advisory Group member to the Interim Administrative Director at the address above. Questions should be directed to Dave Gibbons, Interim Administrative Director, at 907/278-8012; or to Doug Mutter, Public Advisory Group Designated Federal Officer, at 907/271-5011.

Information Packet

Nominees for an alternate to a Public Advisory Group member should provide the following information:

- A biographical sketch (education, experience, address, telephone);
- Information about the nominee's knowledge of the region, peoples or principal economic and social activities of the area affected by the *Exxon Valdez* oil spill, or expertise in public lands and resource management;
- Information about the nominee's relationship/involvement with the principal interest to be represented;
- A statement explaining any unique contributions the nominee will make to the Public Advisory Group and why the nominee should be appointed to serve as an alternate; and
- Any additional relevant information that would assist the Trustee Council in making a recommendation.

Conflict of Interest

Public Advisory Group members and their alternates are chosen to represent a broad range of interests. It is possible that action could be taken by the Public Advisory Group when one or more of the members have a direct personal conflict of interest which would prejudice and call into question the entire public process. To avoid this eventuality and to enable the Trustee Council to choose appropriate individuals as alternates to Public Advisory Group members, it is necessary that each nominee for alternate provide the following information with their information packet. If the answer to any of these questions is yes, please provide a brief explanation of your answer. A yes will not necessarily preclude any nominee from being appointed to serve as an alternate to a member of the Public Advisory Group.

- Do you, your spouse, children, any relative with whom you live or your employer have, or are you defending, a claim filed before any court or administrative tribunal based upon damages caused by the *Exxon Valdez* oil spill?
- Do you, your spouse, children, any relative with whom you live or your employer own any property or interest in property which has been, or is likely to be, proposed for acquisition by the Trustee Council?
- Have you, your spouse, children, any relative with whom you live or your employer submitted, or likely will submit, a proposal for funding by the Trustee Council?
- Do you know of any other potential actions of the Trustee Council or the Public Advisory Group to have a direct bearing on the financial condition of yourself, your spouse, children, other relative with whom you live or your employer?
