The purpose of this letter is to respond to your requests for no cost contract extensions for two SEA projects. Specifically, you requested that funds remaining from the Physical Oceanography (320M) and Nekton and Plankton Acoustics (320N) projects within the contract period ending April 15, 1998 (FY1997/1998) be carried forward to allow the Principal Investigators to continue working on these projects.

I appreciate your efforts to contain costs and understand that you are concerned about the total amount of funding necessary to close-out the projects. However, as a general rule the unexpended and unobligated balance of a project lapses on September 30 of the fiscal year for which the project was approved or the end of the contract period.

In reviewing your request it appears that you are asking that these funds be extended to cover work outlined in your Fiscal Year 1998 proposal which ends April 15, 1999. If you believe that insufficient funds were provided in Fiscal Year 1998 to address the final field season and close-out of the projects, I would strongly urge you to submit requests for additional funding. These then will be reviewed along with other funding requests for Fiscal Year 1999.

Please be advised that the deadline for submittal of all proposals is April 15, 1998. In addition, proposals of this nature must also be submitted through the BAA process by 2:00 p.m. Pacific Standard (Seattle) time on April 15, 1998.

Please find enclosed several documents that collectively describe the terms and conditions of the court approved 1991 civil settlement with Exxon. These include:

- the **Agreement and Consent Decree** entered into by the United States, the State of Alaska, Exxon Corporation and Exxon Shipping Company, and Exxon Pipeline Company that provides for the payment of monies by Exxon to the federal and state governments;
- the **Governments' Memorandum in Support of the Agreement and Consent Decree**; and
- the **Memorandum of Agreement and Consent Decree** entered into by the United States and the State of Alaska that establishes the respective governments as co-trustees for the joint collection and use of the settlement payments from Exxon.

Subsequent to the settlement, in order to formulate a comprehensive and balanced restoration program, the Trustee Council undertook an extensive public process that included preparation of a full Environmental Impact Statement (EIS). A copy of the *Exxon Valdez* Oil Spill Restoration Plan, officially adopted by the Trustee Council in November 1994, together with the Update on Injured Resources and Services, adopted by the Trustee Council in September 1996 is also enclosed. (If you would like a copy of the EIS or the Record of Decision, a copy may be obtained from the Restoration Office.)

Finally, I have also enclosed a copy of the Trustee Council's most recent 1998 Status Report, as well as two issues of the *Restoration Update* newsletter, which provide an overview of current and on-going restoration program activities.

Re: Emergency Exit Procedures

In case of an emergency in the Simpson Building, you should know the following:

EMERGENCY EXIT: If there is an evacuation type emergency, use either stairwell. **DO NOT USE THE ELEVATOR.** If you use the back stairs, you will exit in the alley between the Simpson Building and City Hall.

On the landing of the fourth floor back-stairwell, is an intercom connected to a speaker in the lobby of this building. The Anchorage Fire Department has a file on this building and is aware of the existence of this intercom. In case of an emergency, the dispatcher would inform the responding crew of the intercom and that area would be checked (via the intercom) when they enter the building. If anyone needing to exit the building had special needs they would stay at the intercom, and would be rescued from that area. If emergency personnel were in the lobby, you could talk with them via the intercom. To exit the building, you would descend the back stairwell. You will encounter a door at the second floor level. The door is not locked if you are going down, but it *is* coming up. If a staff member used a wheelchair, we should pass this information along to Jack White and the Fire Department.

DESIGNATED MEETING PLACE: The designated meeting place is the parking lot behind City Hall and the Simpson Building. There are benches in the treed area that would be the place to gather. We will take a head count when everyone shows up.

FIRE: There are two pieces of fire extinguisher equipment in the hallway on the east wall between the men's restroom and Jeff's office door. One is a foam fire extinguisher and the other is a fire hose.

The small portable extinguisher is the type you have in your home. The instructions are on the label in steps.

Step 1 break yellow seal and pull ring pin.

Step 2 Start from 8 feet back.

Step 3 Aim at base of fire. Use extinguisher upright.

Step 4 Squeeze lever. Sweep side to side.

The extendable fire hose looks simple to use. Unhook the nozzle, extend the hose and if possible, have another person turn the water on by rotating the red handle to the left. Again, aim at the base of the fire and sweep from side to side.

If heavy smoke is an issue, drop to the floor and crawl to the stairwell and out of the building.

EARTHQUAKE: Get under your desk or stand in a sturdy doorway (not a partition doorway). If exiting the building becomes necessary, use the back stairwell, if possible, as the front stairwell leads to a glass wall in the lobby that could be a hazard.

SEVERE STORM/TRAVELER'S ADVISORY: If the situation warranted, the senior staff person may send staff home early.

PRACTICE FIRE DRILL: We will have a practice fire drill within the next few weeks. You will hear a page via the speaker on your office phone.

EMERGENCY EXIT BUDDIES: To help ensure everyone gets out of the building we will each have exit buddies. Your office neighbor will be your exit buddy, for instance: Stan and Tami, Molly and Rebecca, Eric and Keri, Joe and Cherri, Sandra and Veronica, and Jeff and Hugh.

NOTIFYING OTHER BUILDING TENANTS: Hopefully, one of us will have the opportunity to grab a cell phone which will allow us to contact the building maintenance people and inform them of the emergency. They will be responsible for contacting the other building tenants.

The purpose of this letter is to request that the Court Registry Fee associated with the *Exxon Valdez* Oil Spill Settlement Account (CRIS - Liquidity Fund) be reviewed.

Pursuant to 56 Fed. Reg. 56356 (Nov. 4, 1991), a fee of 10 percent is to be assessed for the first five years. For each five-year interval, the fee is then reduced by 2.5 percent. Since the first investment in the Court Registry Investment System occurred on December 13, 1991, the reduction on the Registry Fee should have taken effect on December 13, 1996.

An external audit performed by the firm of Elgee, Rehfeld and Funk has determined that the reduction in Registry Fee did not take effect until January 30, 1997. This means that the CRIS - Liquidity Fund was overcharged approximately \$13,300 during the period December 13, 1996 through January 29, 1997.

As a result, I request that the Registry Fee overcharge be remitted to the CRIS - Liquidity Fund. I further request that the final adjustment be compounded to recognize lost earning potential and that a report detailing the final adjustment be provided to this office.

LONG TERM RESTORATION

Long term restoration is the goal of Restoration Reserve funds. Since the fund will be worth \$150. million by 2002 the Trustee Council is in the extraordinary position of being able to protect subsistence, recreation, tourism, and commercial fishing within the spill-region.

Trustees did a good job and their Council's structure must be retained to preserve the continuity vital to long term major projects like restoring Alaska after the Exxon Valdez Oil Spill.

Most certainly Restoration Funds must be used to protect wilderness habitat upon which Alaskan's precious renewable resources and Kenai Peninsula's top industries depend. Tourism and fishing are the major job providers for peninsula residents, according to Alaska Labor Dept.

SABOTAGE

However a major effort is a-foot by special-interest group industrialists in league with multi-national corporations to strip Alaska of her resources and Alaskans of their livelihoods. Oil and Logging barons have money enough to buy political-aid from Congressmen, state politicians, and borough mayors while offering meager local employment and draining Alaska's wealth. Poverty, pollution, and eco-destruction is left in their wake. Witness the Exxon- Valdez Oil Spill.

Alaska's US Senator Frank Murkowski, a prime supporter of out-of-state loggers and oilers, seeks to block the Council's ability to buy and preserve land with Restoration Funds. Habitat protection threatens the interests of his multi-national corporation constituents and their ability to bleed our state for personal gain.

The Kenai Peninsula, once Alaska's Tourism Jewel, is a case in point. Coast lines coated with crude Exxon are just now regaining their ability to produce subsistence food for Native Alaskans culturally dependent on pristine habitat. While salmon stocks remain in trouble the state is pushing massive oil-drilling against residents' wills and is spite of ecosystems struggling to regain health.

ACQUISITION IS THE KEY TO PRESERVATION

Only the Council has the money and power to parry this assault on Alaska by acquiring and protecting wilderness. Some areas within the spill region never received aid to cope with their injuries and are now under further attack.

An example is the head of Kachemak Bay (an important breeding ground for marine life and terrestrial animals) known as the only major moose calving ground on the Kenai Peninsula. The surrounding roadless old-growth forest stretches

to Soldotna and shades vital salmon streams feeding Kachemak Bay and Cook Inlet.

Here is the home of commercial hatchery salmon and endangered wild-fish stocks, halibut, flounder, clams, and shell-fish. Yet nothing was done when Exxon's oil-sheen hit.

No samples were taken when Kachemak Bay clams at the mouth of Fox Creek surfaced en-mass killed by a black tar they retained in their shells. No samples were taken of the foul green gunk laced with dead sea-life that continues to wash ashore.

Government subsidized cattle grazing, Bradley Dam construction, the Exxon spill, wildlife poaching, and long term squatting have depleted the head of Kachemak Bay perhaps to the point of no return. Its time to STOP.

Virtually unregulated logging is gobbling trees protecting salmon streams crucial to Kenai Peninsula sports and commercial fishing. Wildlife whose salmon and shell- fish diets were impoverished by the Spill are dying or being shot as their forest home turns to square miles of mud and stumps.

According to DNR's Deep Creek Management Plan (not being followed) and Alaska's Fisheries Atlas (1978) four important spawning streams exist in this area. They are Deep Creek, Stariski Creek, Fox Creek, and Anchor River all now subjected to logging sedimentation while no government water-samples are taken and the Forest Practice Act goes unenforced.

There could be no better use of Restoration Reserve funds than to save this orphan-area of the Exxon Spill by acquiring habitat in this marine and forest ecosystem vital to Kachemak Bay and Cook Inlet communities. Local economies will be preserved-- subsistence, fishing, recreation, and tourism protected.

Spin-off from habitat acquisition in the Deep Creek Management Area will be the reward of saving fantastic Kenai Peninsula Brown Bears from the brink of extinction. K.P. Brown Bear meet all criteria for listing as a threatened species, says a US Forest Service report by Lowell Suring.

As Oregon-Washington loggers cut Kenai Peninsula forests for quick sale to Japan Ak. Fish and Game says Brown Bears are being shot in record numbers.

"The Forest Practice Act goes unenforced and DNR's Use It Or Lose It timber policy is causing habitat destruction and salmon stream silting. Logging is leading to salmon loss, bear decline, moose-habitat destruction, and salmon stream silting says AK. Fish and Game in a '95 report.

Kenai Peninsula Brown Bear habitat is being destroyed, says Suring. The bears are over-hunted, he says. "Data on K.P. Brown Bear's survival requirements is lacking. They're probably an isolated population with no ability to escape," Suring says.


