Dear Ms. Severson:

Thank you for your recent comment in support of the *Exxon Valdez* Oil Spill Trustee Council's efforts to protect important habitat on Afognak Island.

At the most recent Trustee Council meeting on May 9, the Council formally proposed an offer to purchase lands on northern Afognak Island and allocated \$70 million for this purpose. If accepted by the land owner, this would make the Afognak Island acquisition the largest single commitment of funds for a land purchase by the Trustee Council.

As you may be aware, the lands on northern Afognak have exceptionally high timber values and the landowner is actively involved in timber harvest. In an effort to maximize the amount of land to be protected, the Council developed an offer that consists of two components. The first element of the offer provides for outright purchase of 20,000 acres in the Laura and Paul's Lake area which includes some of the highest ranked habitat evaluated in the entire oil spill area. The second element includes a provision to acquire an additional oil spill area. The second element includes a provision to acquire an additional 27,000 acres that would be subject to a negotiated, limited timber harvest plan. The State of Alaska would take title to the land following the timber harvest.

While outright purchase of all these lands would be the preferred option, the extremely high timber values required that the Council try and develop a proposal that would protect the maximum acreage possible. This offer is now pending before the landowner and we hope that it will be accepted. Thank you again for your comment.


