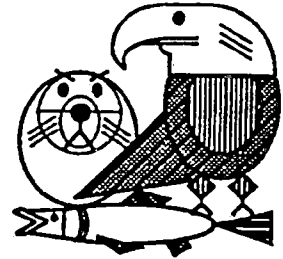

We, the undersigned, duly authorized members of the *Exxon Valdez Oil Spill Trustee Council* do hereby certify that, in accordance with the Memorandum of Agreement and Consent Decree entered as settlement of United States of America v. State of Alaska, No. A91-081 Civil, U.S. District Court for the District of Alaska, and after public meetings, and the opportunity for, and consideration of, any written comments from the public, unanimous agreement has been reached to expend funds received in settlement of United States of America v. Exxon Corporation, et al., No. A91-082 Civil, U.S. District Court for the District of Alaska, and State of Alaska v. Exxon Corporation, et al., No. A91-083 Civil, U.S. District Court for the District of Alaska, for necessary natural resource damage assessment and restoration activities for federal fiscal year 1994 from October 1, 1993 to September 31, 1994. The total approved budget, appended hereto, is \$16,928,500.00.



In accordance with the Financial Operating Procedures adopted by the Trustee Council, the amount of funds requested from the Joint Trust Fund is to be reduced by the amount of interest previously earned from settlement funds held by the Federal and State governments and any unobligated fund balances from previously approved budgets. Since the last disbursement from the Joint Trust Fund, the amount of interest earned is \$22,427.00 for the United States and \$180,535.59 for the State of Alaska. Accordingly, the amount to be withdrawn from the fund will be reduced by \$202,962.59 because of interest earned. The unobligated balance for the fiscal period from March 1, 1992 to September 30, 1993, is \$3,106,555.00 for the United States. The unobligated balance for March 1, 1992 to February 28, 1993 for the State of Alaska was subtracted from a prior court request. The unobligated balance for March 1, 1993 to September 30, 1993 for the State of Alaska will be determined at a later date and subtracted from a subsequent court request. The amount to be withdrawn from the fund with this request will be reduced by \$3,106,555.00 because of the unobligated balance.


By unanimous consent, we hereby request the Attorney General of the State of Alaska and the Assistant Attorney General of the Environmental and Natural Resources Division of the United States Department of Justice to petition the United States District Court for the District of Alaska for withdrawal of the sum of \$13,618,982.41 from the Court Registry account established as a result of the governments' settlement with the Exxon companies. Of this amount \$1,407,818.00 shall go to the United States of America and \$12,211,164.41 shall go to the State of Alaska.
