Statement of Purpose and Need:

It is time to re-assess the existing Exxon Valdez Environmental Impact Statement (EIS), which was created in 1994. The Exxon Valdez Trustee Council chooses to do so with the creation of a Supplemental EIS (SEIS). The Council undertakes the creation of a SEIS so that two goals may be reached, 1) the Council would like to respond to significant new circumstances that bear on the Council's restoration efforts as assessed in the original EIS and 2) as the restoration funds remaining from the settlement diminish, the Council seeks a more efficient administrative structure by which to manage remaining funds.

Public Participation:

Comments from the public will help the Trustees to shape the scope and scale of the Draft SEIS document. The Trustees want to incorporate and address public concerns from the beginning. This entire process is referred to as the public scoping process and the Trustees would like to receive your comments with regard to this undertaking. They are particularly concerned with your thoughts on future restoration activities taken on by the Trustee Council. It is most helpful for the Trustees to hear your thoughts on where and what kind of future restoration actions will take place, how will those actions impact the environment, social and economic interests, measures to avoid or lessen negative impacts, alternatives to consider, and suggestions on restoration priorities and projects. The more specific your comments are, the more useful they will be to this process.
