The Community Profile Database (CPDB) is a large, interactive computerized system designed for continuous updates. These unique characteristics affect duplication procedures. There are essentially three ways for the public to obtain copies of the database in whole or part. First, the best way to obtain the database is on computer diskette for use on a personal computer with the RBASE software program. Second, each Division of Subsistence regional office, and two libraries in Anchorage, have a printed version of the database that may be looked at by the public free of charge. Third, the printed version of the database may be borrowed from the Division of Subsistence Anchorage or Juneau Headquarters offices for duplication at the user's expense (typically, private duplicating services charge from \$.08 - \$.10 per page). The Division of Subsistence can duplicate up to 20 pages at no charge.

Of these three methods, the first (computer diskette version) is by far the least expensive method for reproduction, as shown below. As a computer diskette version, the database can be used efficiently and effectively. It also can be updated relatively inexpensively. The second method (looking at the database in the regional office) is good if there are a few select communities or areas that a person is interested in. However, it is less desirable if large portions of the database are to be used. The third method requires considerable costs for duplication. Because the database is continually updated, the Division of Subsistence does not produce large numbers of printed copies, as the version becomes quickly superseded. Consequently, reproduction costs of single printed copies are necessarily greater and more time consuming to make, particularly because of the large number of pages of the database in the printed version. For users who feel they must have a printed version, we recommend the third method, borrowing a copy for duplication, or selecting a local Juneau or Anchorage copying service to who we supply a copy master. Each of these methods is described below in more detail. Also included is ordering and cost information on CPDB related products, the CPDB Supplement and the User's Guide to the CPDB.

Method 1. Computer Diskette Version

This is the best method for obtaining the database. To use the diskette version, you will need to have the R:BASE software program, and 19.9 MB hard drive space (23.7 MB of hard drive space are required during installation of the database). The user provides the Division of Subsistence with four high density diskettes for the database, and one diskette for the Technical Documentation, and we will copy it for free. Or you may choose to obtain a diskette version of the database itself, and a print version of the Technical Documentation, using Method 3 described below.

On July 11, I spoke with Cherie Shelley, acting regional NEPA and Appeals Coordinator, at the Forest Service about their retention policy for documents that have been referenced in an EIS. According to Cherie, the physical document (original or photocopy) used as a reference source in an EIS, needs to be housed on site as part of the administrative record.

The references cited in the DEIS warrant careful consideration to avoid possible legal ramifications. Cherie cited a case where they were sued because a number of University of Washington archaeological reports were housed in Ketchikan instead of on site. Documents housed off site also pose a potential problem if the document in question is missing from the shelf or is checked out of the collection.

Acquisition of this documentation for inclusion in the administrative record is a labor intensive and, perhaps, costly task. The bibliography (including the references cited at the end of Appendix C) has to be checked to determine which documents are currently housed at the OSPIC. Reproduction of journal articles may have to be obtained by reporting the photocopies and paying the publishers' fees through the Copyright Clearance Center. In some cases, permission to retain a portion of documentation may have to be granted by the author. In other cases, if an entire journal or book has been cited, purchase of the issue or book may be the best alternative.

The potential large volume of material generated from these documents may also necessitate the need for additional filing cabinets to be placed in the OSPIC.

Individuals involved in the planning and writing of the DEIS, may have retained copies or may be able to easily acquire some of the referenced documents. In addition, your budget may cover any necessary reproduction costs. Your help and cooperation in obtaining these documents is greatly appreciated. With your





Copyright Clearance Center, Inc. (CCC) is a not-for-profit clearinghouse which provides one-stop shopping for photocopy permissions to a wide range of users. <u>TITLES and FEES</u> is the guide to the over 1.5 million titles that are registered with CCC and is used by those who report and pay for photocopying through the Transactional Reporting Service (TRS) as well as those organizations who have an Annual Authorizations Service (AAS) license with CCC. Over 4,500 corporate entities and their employees are licensed with CCC, and over 1,300 organizations use the TRS. This edition of <u>TITLES and FEES</u> reflects CCC's database of authorized titles through May 13, 1994 and replaces the *COPI* and *Schedule A* catalogs you may be accustomed to using. A User's Guide has been added to help you follow the changes in format.

If your employer has a Transactional Reporting Service (TRS) account, you should read all the appropriate instructions and information referenced in the Table of Contents. A TRS account requires that all photocopies be reported transactionally using the information specified in this catalog. Photocopying is recorded either electronically or on a log sheet and reported to CCC monthly or quarterly. Complete instructions and log sheets are provided. 
