Annual Work Plan (Summary)

The objective is to publish a final Restoration Plan by June 1994. This assumes the first of two schedules recently prepared by Mark Brodersen and Ken Rice (see their memo of July 1, 1993 to Restoration Team). This schedule assumes that the Draft Restoration Plan will be available for public comment in January 1994. The Trustee Council will either approve or amend this schedule during their August 1993 meeting. It also is assumed that the Working Group will disband upon completion of the final Restoration Plan.

Specific Tasks

1. Develop Draft Restoration Plan

The Plan should include some or all of the following components pending Trustee Council guidance:

- a. policy guidelines (five policy issues presented in April 1993 Summary of Alternatives);
- b. guidelines for prioritizing restoration actions;
- c. definitions of recovery for injured resources and reduced or lost services (where possible);
- d. procedures for evaluation of potential restoration actions;
- e. Action (recovery) plans for injured resources and reduced or lost services; and

f. descriptions of habitat protection process, monitoring program, and possibly use of endowments.

The Draft Plan will be ready for review by the Restoration Team, Chief Scientist, and Peer Review Team in October 1993. Legal Review is scheduled for early November 1993, with final review and approval by the Trustee Council scheduled for December 1993. Distribution to the public will occur in early January 1994. If resource action (recovery) plans are not included in the Draft Restoration Plan (this assumes a policy level document), the Draft Plan could be ready for distribution one month earlier.

2. Coordinate public comments on Draft Restoration Plan

The Planning Group will summarize and synthesize public comment for Trustee Council consideration in February 1994. The Working Group's report will be available for review and comment by the Restoration Team in early March 1994, with ultimate review and consideration by the Trustee Council in late March 1994.

3. Develop final Restoration Plan

Based on guidance provided by the Trustee Council, the Planning Group will revise the Draft Restoration Plan in April 1994. The Planning Group will seek appropriate review from the Restoration Team, Chief Scientist, Peer Review Team and the Legal Team before again submitting the document to the Trustee Council in May 1994 for their final review. Revision and distribution of the final Restoration Plan will occur in early June 1994.

Constraints

There is substantial uncertainty associated with the above schedule and budget. Until the Trustee Council decides which components are included in the Restoration Plan or in annual work plans, and they deal with NEPA compliance, we are perhaps best advised to assume 12 months funding for RPWG in FY-1994. For example, if the Trustee Council opts for inclusion of resource actions plans in annual work plans, the planning process will undoubtedly be extended thru August 1994, when the 1995 Work Plan will be distributed. We could always re-think and revise our schedule and budget at such time the Trustee Council provides explicit guidance.

Annual Work Plan (Summary)

The objective is to complete a final Restoration Plan by June 1994. This assumes the first of two schedules recently prepared by Mark Brodersen and Ken Rice (see their memo of July 1, 1993 to Restoration Team). This schedule assumes that the Draft Restoration Plan will be available for public comment in January 1994. The Trustee Council will either approve or amend this schedule during their August 1993 meeting. It also is assumed that the Working Group will disband upon completion of the final Restoration Plan.

Specific Tasks

1. Develop Draft Restoration Plan

The Plan should include some or all of the following components pending Trustee Council guidance:

- a. policy guidelines (five policy issues presented in April 1993 Summary of Alternatives);
- b. guidelines for prioritizing restoration actions;
- c. definitions of recovery for injured resources and reduced or lost services (where possible);
- d. procedures for evaluation of potential restoration actions;
- e. Action (recovery) plans for injured resources and reduced or lost services; and
- f. descriptions of habitat protection process, monitoring program, and possibly use of endowments.

Action plans for each injured resource and reduced or lost service will be developed with the assistance of agency scientists and the Peer Review Team (including Chief Scientist). This effort will

begin in July 1993 and essentially be complete in October 1993. This process could be extended through August 1994 if it is determined that action plans are better included in the annual work plan (1995 Work Plan) rather than included in the Restoration Plan. The Draft Plan will be ready for review by the Restoration Team in October 1993. The Draft Plan will be reviewed by the Legal Team in early November 1993; the document will ultimately be reviewed and approved by the Trustee Council in December 1993. Distribution to the public will occur in early January 1994.

2. Coordinate public comments on Draft Restoration Plan

The Planning Group will summarize and synthesize public comment for Trustee Council consideration in February 1994. The Working Group's report will be available for review and comment by the Restoration Team in early March 1994, with ultimate review and consideration by the Trustee Council in late March 1994.

3. Develop final Restoration Plan

Based on guidance provided by the Trustee Council, the Planning Group will revise the Draft Restoration Plan in April 1994. The Planning Group will seek appropriate review from the Restoration Team, Peer Review Team (includes Chief Scientist), and the Legal Team before again submitting the document to the Trustee Council in May 1994 for their final review. Revision and distribution of the final Restoration Plan will occur in early June 1994.
