Structure

Delete Appendix B, Affected Environment.

Move Chapter 2, Injury, to Appendix B.

Incorporate "Summary of Injury" from brochure into the old Chapter 3 (new Chapter 2), Restoration Alternatives. Split into two chapters: Chapter 2, "Information to Understand the Alternatives", and Chapter 3, "Restoration Alternatives."

Editorial

Paginate plan text, figures, and tables consecutively.

Each chapter author should search for the hyphenated versions of the following words and replace with: prespill, cleanup, noninjured, postspill, haulout, nearshore.

Each chapter authors should search for Trustees and replace with Trustee Council except the one place in Chapter 1 that says, "Federal Trustees have appointed a representative to the Trustee Council."

Table of Contents

More detailed breakdowns.

Chapter 1

- p. I-1, ¶ 3 Delete the first two and a half lines and begin sentence with "The Draft Environmental..."
- p. I-7, ¶ 3 In sentence describing membership on PAG, split out ex-officio members. "17 member representing interest groups and 2 ex-officio members designated by the legislature."

Chapter 2

Add a Table of Contents.

Table 2-1 (referring to "other birds") is missing.

There are two tables numbered Table 2-1. Renumber one.

Add language from the table to the sections on clam and shrimp.

The tables need an introduction. It has been written in an earlier version and is on the network. (Ask Bob.)

Chapter 3

Split into two chapters: Chapter 2, "Information to Understand the Alternatives", and Chapter 3, "Restoration Alternatives."

p. 3-3, ¶ 6 New issue should be moved to Geographic Location.

<u>Chapter 4</u> No major changes.

Appendix A No major changes.

<u>Appendix B</u> Delete "Affected Environment." Move the old Chapter 2 into this appendix.

Appendix C No major changes. Bob will make the changes agreed upon on Monday. He has discussed these changes with Art.

Appendix D

The appendix should be sent to Bob Spies for his review as soon as possible. Karen will discuss with him the definitions of the terms "rate of recovery" and "degree of recovery," today if possible.

Add definition of General Restoration option to the introduction.

p. D-20 Option 3, delete "and implement actions to remove adverse effects."
