LOCATION: The location to which this reservation is appurtenant is the stream flow within South Fork Campbell Creek and its floodplain, from the mouth of South Fork Campbell Creek to approximately River Mile 5. Said portion of the South Fork Campbell Creek is located within Township 12 North, Range 2 West, Section 2 & 3; and Township 13 North, Range 2 West, Sections 31 & 32; and Township 13 North, Range 3 West, Sections 33, 34 & 36 all within Seward Meridian and the Anchorage Recording District, Third Judicial District, State of Alaska.

This Certificate of Reservation is granted subject to the certificate holder's continuous compliance with the conditions listed below.

- 1. This reservation of water is subject to review under AS 46.15.145 (f). A review under AS 46.15.145 (f) shall be initiated not later than March 19, 2015.
- 2. Except for claims or losses arising from negligence of the State, the holder of this certificate shall defend and indemnify the state against and hold it harmless from any and all claims, demands, legal actions, loss, liability and expense from injury to or death of persons and damages to or loss of property arising out of or connected with the exercise of the water right granted by this certificate.
- 3. The holder of this certificate shall comply with all the applicable requirements of AS 46.15.010 – 46.15.270 and 11 AAC 93.010 – 11 AAC 93.970, now effective or as they might in the future be amended.
- 4. The holder of this certificate shall notify the grantor of any change of address, or change of water use conditions.
- 5. The certificate of reservation may not be voluntarily abandoned, conveyed, transferred, assigned, or converted to another use, in whole or in part, unless required as a result of review under 11 AAC 93 147
- 6. The certificate of reservation does not authorize the certificate holder or any other person to prevent access to, on, or through the water reserved by the certificate, or to prohibit the use of the reserved water for other compatible purposes set out in AS 46.15.145(a).
- 7. Pursuant to AS 46.15.145(f) this reservation may be modified to reduce the flows reserved under this reservation but cannot be modified to increase the flows.
