APPENDIX #2 OCCUPANT INFORMATION

The information presented is considered confidential and is not to be released to the public. Much of the following information is preliminary and has not been verified by BLM.

Peter Browne

Mr. Browne is the principal mining claimant at Flat. Mr. Browne appears to be in his 40's, is of good health. His family has held the claims since approximately 1920, at which time Mr. Browne's father, Bob Browne, acquired all of the Guggenheim mining interests in Flat. Mr. Brown lives in the Alaska Road Commission Repair Shop during the summer months and resides in the lower 48 during the winter. Mr. Brown conducted BLM 3809 notice level mining activities during the early 1980's, but has not submitted a 3809 notice since. Mr. Browne has stated that he will be resuming mining activities next year, and will be filing a 3809 notice this winter. Mr. Browne has filed a occupancy work-sheet with BLM.

Fullerton

The Fullerton Family has been in Flat for three generations. Their main camp is approximately 15 miles from Flat, on Willow Creek, and is connected to Flat by a good State maintained road. The family consists of John Fullerton who is in his late 70's, his wife Jane, and his son Tad who is approximately 40. recent years they have been mining on Flat Creek, just outside of They have for some time been conducting the largest and most diligent mining operation in the area and are currently under a BLM 3809 Plan of Operations. The Bureau has conducted annual inspections of the mining each summer since the mid 1980's. They are highly respected in Flat and the mining community. They mine from May through early October, and reside in Seattle during the winter months. Tad sometimes over-winters The Fullertons have filed an occupancy form and worksheet with BLM.

John Miscovich

John Miscovich is a second generation Flat resident, born and raised in Flat, and is considered one of the grand old men of the Alaska mining community. A trained mining engineer, he invented mining equipment that is still used worldwide. He resides in a mining camp approximately two miles out of Flat which is connected by a good State maintained road. John is 80 years old, but a vigorous man for his age. He has conducted BLM 3809 notice

level operations for many years and is an active promotor of Flats hardrock potential. The Bureau has conducted annual inspections of the mining each summer since the mid 1980's. Mr. Miscovich and his wife Mary spend the summers in Flat, but for a number of years have maintained a winter residence in Orange County, California. They have a daughter who used to help her father mine, but she has not been spending much time in Flat in recent years. John used to hold the mining claims under the airstrip, but dropped them a few years ago to qualify for a small miners exemption when BLM instituted mining claim fees. John has filed an occupancy form and work-sheet with BLM. Mary Miscovich

Alvin Agoff

Alvin Agoff is a second generation miner who has been mining on Prince Creek since he was a teenager. He is now in his late 60's or early 70's. His mining camp is the most remote of the outlying camps around Flat, although it is connected to Flat by relatively good road. Alvin has a notice level mining operation which he now runs single handedly with the sometime help of an older daughter. The Bureau has conducted annual inspections of the mining each summer since the mid 1980's. Alvin used to overwinter in Flat, but when his kids got older he and his wife, who just died of cancer, acquired a residence in Palmer where his kids could go to school. Alvin has filed an occupancy form and work-sheet with BLM.

Ann Willaims

Ann Willaims, who is John Miscovich's sister, was born and raised in Flat where she has lived entire life. Now in her late 60's or early 70's, Ann has significant health problems. Ann and her husband mined in the area for many years on Bonanza Creek, until her husband fell into the creek a few years back and drowned. Despite prompts from several BLM employees, Ann failed to file her assessment work and lost her mining claims. With no opportunity to restake her claims, she moved to a cabin in town. Since her husband died, Ann has been spending the winters in Anchorage. Ann has not filed an occupancy form with the BLM, but regularly calls BLM about various local concerns.

Kepler

The Keplers purchased the Brink House in 1984, and have resided in Flat full-time since 1987 with their three children, which they home school. Mark Kepler is the Postmaster for Flat and does the airstrip maintenance for the State. Sherry is his wife. The Keplers are in their mid-30's. The Kepler family is very popular with the local miners as they help look after things when they are not present. Essentially they are the unofficial "Flat Caretakers." They have been very interested in researching the history of the area. They have purchased and extensively repaired several buildings and have stated they have invested everything they have in Flat. While they have not filed any

paperwork with BLM, they have had a number of conversations with BLM about legitimizing their occupancy.

The Dahl family has been associated with Flat for many years. The family inherited the buildings from John Stevens, who had bought out the Matheson interests in approximately 1960 for Two brothers died in a airplane crash near Flat during \$20,000. the 1980's. Rob Dahl is a part owner in the core mining claims at Flat. He works in Bethel at the prison and commutes regularly between Flat and Bethel. His family resides full-time at Flat. The family is Native-Alaskan with a number of small children. Mr. Dahl reportedly earns a good salary working as a prison guard. They have stated that they are living in Flat because they believe it is a good place to bring up their children. Dahl has submitted a work-sheet and has stated that he will be submitting a 3809 notice in FY 99. The Dahls have never filed a 3809 notice before.

Reportedly from Anchorage, he wanted to run a guiding service out of Flat at one time. He is a partner with Steve Welles on building IDT-092. BLM has had no communication with Mr. Harris.

Reportedly from Anchorage. Partner with Don Harris on Building W-1, IDT-092, the Gus Uotila house, otherwise known as Tootsie's place. Originally bought from Phillip Edwards and/or Mike Demientieff. Mr. Welles has guided German hunters out of Flat in the past with limited success (not enough game in area). BLM has had no communication with Mr. Welles.

<u>Mike Demietieff</u> Originally from Holy Cross, he and his wife owned several buildings and lived in Flat full-time from the mid 1970's through the 1980's. Reportedly, he and his wife passed away during early 1990's.

Artie Demietieff

Mr. Demietieff allegedly owns the Awe/Webber/Gularte/Hubbard/Brink House. Mr. Demietieff is reportedly the manager of the Aniak electrical plant, and a member of a regionally large and prominent Native/Russian family. He has not filed any paperwork or had any communication with BLM.

Shawn Flemings

The Fleming brothers reportedly spent their childhood in Flat before moving to Iditarod. He and his brother now reportedly reside in Bethel. He has not filed any paperwork or had any communication with BLM.

Jimmy Flemings

The Flemings brothers reportedly lived in Iditarod during the early 1970's before moving to Flat. He and his brother now reside in Bethel and have not filed any paperwork or had any communication with BLM.

Olsen

Darrell Olsen, also known as "Freight Train", is from Wasilla. He purchased IDT-168 sometime during the 1970's. A family named Olson used to mine over on Happy Creek and were reportedly one of the first mechanized miners in the Flat area. They have not filed any paperwork or had any communication with BLM.

Dan Crammer

Mr. Crammer is reportedly associated with the Olsen brothers. BLM has had no communication with Mr. Crammer.

Dave Wintz

Mr. Wintz is reportedly a building contractor. The Wintz family has a long history in Flat. BLM has had no communication with Mr. Wintz.

Burttoy Wintz

Mr. Stock is a retired ex-Bethel city manager and engineer, resided part-time in Flat during early 1990's. Mr. Stock had an arrangement with John Miscovich to use a couple of his buildings. Mr. Stock had failing health in the early 1990's and it is not believed that he is still residing in Flat. Reportedly, he never owned any of the buildings. He has not filed any paperwork or had any communication with BLM.

Glen Johnson

A bush preacher, who used to live and work out of Aniak, he and his wife Dorthy are now retired in Soldotna. Mr. Johnson began purchasing buildings in Flat during the 1970's. He has since sold many of the structures to friends and associates. BLM has had no communication with Mr. Johnson.

Crabtree

An associate of Glen Johnson, Mr. Crabtree is reportedly a contractor from Soldotna. BLM has had no communication with Mr. Crabtree.

Darrel Snodgrass

Mr. Snodgrass is an associate of Glen Johnson who also resides in Soldotna. BLM has had no communication with Mr. Snodgrass.

Jim Cruise

Believed to be an associate of Glen Johnson who lives in Nikiski or Soldotna. Mr. Cruise has extensively remodeled and improved has structure. BLM has had no communication with Mr. Cruise.

Jeff Darling

Reportedly Mr. Darling was going to lease part or all of the Matheson buildings from the Dahls in the early 1990's. It is not known if this happened or if Mr. Darling has any property interest in Flat at this time.

U.S. Postal Service

The U.S. Postal Service has maintained an office in Flat for many years. They have not filed any paperwork or had any communication with BLM.

Bureau of Land Management

The BLM owns a storage shed off the airstrip where the Bureau and the State of Alaska regularly store fuel during fire season. Due to the remoteness of the area the fuel is critical to fire suppression and various resource management projects. The structure was built in 1972 or 1973 by BLM fire crews.

- 2. James B. Flemings, same address


I looked at the hunting license records for the name Flemings. Both of the above subjects had licenses using a Flat address back in the 1980's. There were also an older James Flemings and a Kathryn Flemings using a Flat address back in the 1980's.

- 3. George E. Walters, Box 1612, Bethel, AK and 3201 Tarwater Ave, Apt 17, Anchorage There were several George Walters's, but this is the only one from the right area. Phone 543-2340 in Bethel, no phone listed in Anchorage.
- 4. There are six Don Harris's listed in Alaska. The only one close to the right area: Don P. Harris, Box 49, McGrath, AK No phone listed
- 5. There are five Darrell Olsons (or Olsen) in Alaska. Darrell R. Olson lived in McGrath in 1996. His latest address is Box 111228, Anchorage. No phone listed
- 6. There are eleven Glen Johnsons in Alaska. You said that Johnson had moved to Soldotna. There are two Glen Johnsons in Soldotna: Glen R. Johnson, Box 78 Glen A. Johnson, Box 1408. No phones listed for either of the above.
- 7. There are some Wintz's in Alaska, but none named Burttoy.
- 8. I tried various spellings for the Dimentoff name, but found nothing at all. We need to find out an accurate spelling in order to look this one up.
